- 1 AN ACT Relating to consistency with the federal wetland regulatory
- 2 program; adding a new section to chapter 36.70A RCW; and declaring an
- 3 emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 36.70A RCW
- 6 to read as follows:
- 7 (1) The legislature finds that the Congress of the United States
- 8 has enacted, and the president of the United States has approved, a
- 9 policy directive to the United States army corps of engineers that
- 10 requires the use of the 1987 federal manual for identifying and
- 11 delineating jurisdictional wetlands for use in the administration of
- 12 the federal wetland regulatory program. Further, the legislature finds
- 13 that the policy directive to the corps of engineers requires this
- 14 manual to be used until a subsequent manual is adopted in accordance

- 1 with the requirements for notice and public comment of the rule-making
- 2 process of the federal administrative procedures act.
- 3 (2) The purpose of this section is to promote consistency between
- 4 wetlands delineated under this chapter and the federal wetland
- 5 regulatory program administered by the United States army corps of
- 6 engineers, to avoid unnecessary delays and paperwork, to provide clear
- 7 and consistent guidance to the regulated community, local governments,
- 8 and the public of the responsibilities under the state growth
- 9 management act, and to minimize the cost to the public of
- 10 implementation of the growth management act.
- 11 (3) Local governments shall delineate, designate, identify, and
- 12 regulate by ordinance, wetlands within their jurisdiction using the
- 13 criteria contained in the wetland delineation manual used by the United
- 14 States army corps of engineers on the effective date of this act.
- 15 (4) If a subsequent version of the delineation manual is adopted by
- 16 the United States army corps of engineers in accordance with the
- 17 requirements for notice and public comment of the rule-making process
- 18 of the federal administrative procedures, the department of community
- 19 development shall notify the appropriate standing committees of the
- 20 house of representatives and the senate prior to the next regular
- 21 session of the legislature.
- 22 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 23 preservation of the public peace, health, or safety, or support of the
- 24 state government and its existing public institutions, and shall take
- 25 effect immediately.
