- 1 AN ACT Relating to solicitation of signatures on initiative and
- 2 referendum petitions; amending RCW 29.79.490; adding a new section to
- 3 chapter 29.79 RCW; creating a new section; prescribing penalties; and
- 4 declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** The legislature recognizes that
- 7 soliciting signatures on an initiative or referendum petition is a
- 8 constitutionally protected activity and that paying a salary to an
- 9 individual for soliciting petition signatures may not be prohibited.
- 10 However, the legislature declares that there is a strong state interest
- 11 in assuring that there is no fraud practiced in obtaining signatures on
- 12 initiative and referendum petitions and that compensation paid and
- 13 received for soliciting petition signatures that is based in whole or

- 1 in part on the number of signatures collected creates an incentive to
- 2 misrepresent the content or purpose of the petition.
- 3 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 29.79 RCW
- 4 to read as follows:
- 5 Paying or receiving compensation for soliciting signatures on an
- 6 initiative or referendum petition is a gross misdemeanor punishable
- 7 under chapter 9A.20 RCW if any of that compensation is based on the
- 8 number of signatures collected in the course of or as a result of that
- 9 solicitation.
- 10 **Sec. 3.** RCW 29.79.490 and 1975-'76 2nd ex.s. c 112 s 2 are each
- 11 amended to read as follows:
- 12 Every person ((shall be)) is quilty of a gross misdemeanor who:
- 13 (1) For any consideration or gratuity or promise thereof, signs or
- 14 declines to sign any initiative or referendum petition; or
- 15 (2) ((Advertises in any manner that for or without consideration,
- 16 he will solicit or procure signatures upon or influence or attempt to
- 17 influence persons to sign or not to sign, to vote or not to vote upon
- 18 an initiative or referendum petition, or to vote for or against any
- 19 initiative or referendum; or
- 20 (3) For any consideration or gratuity or promise thereof solicits
- 21 or procures signatures upon an initiative or referendum petition; or
- (4)) Gives or offers any consideration or gratuity to any person
- 23 to induce him to sign or not to sign((, or to solicit or procure
- 24 signatures upon an initiative or referendum petition,)) or to vote for
- 25 or against any initiative or referendum measure; or
- (((5))) <u>(3)</u> Interferes with or attempts to interfere with the right
- 27 of any voter to sign or not to sign an initiative or referendum
- 28 petition or with the right to vote for or against an initiative or

- 1 referendum measure by threats, intimidation, or any other corrupt means
- 2 or practice((; or
- 3 (6) Receives, handles, distributes, pays out, or gives away,
- 4 directly or indirectly, money or any other thing of value contributed
- 5 by or received from any person, firm, association, or corporation whose
- 6 residence or principal office is, or the majority of whose members or
- 7 stockholders have their residence outside, the state of Washington, for
- 8 any service rendered for the purpose of aiding in procuring signatures
- 9 upon any initiative or referendum petition or for the purpose of aiding
- 10 in the adoption or rejection of any initiative or referendum measure:
- 11 PROVIDED, That this subsection shall not apply to or prohibit any
- 12 activity which is properly reported in accordance with the applicable
- 13 provisions of chapter 42.17 RCW)).
- 14 <u>NEW SECTION.</u> **Sec. 4.** This act is necessary for the immediate
- 15 preservation of the public peace, health, or safety, or support of the
- 16 state government and its existing public institutions, and shall take
- 17 effect immediately.
