- 9 A bank or trust company that has received a judicial or
- 10 administrative subpoena, summons, or any other request for the
- 11 production of its records is entitled to receive from the requesting
- 12 party reimbursement for the reasonable cost of producing these records,
- 13 only when the cost of producing the records exceeds twenty-five

- 1 dollars. For the purposes of this section the term bank includes a
- 2 state chartered or nationally chartered bank.
- 3 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 31.04 RCW
- 4 to read as follows:
- 5 A licensee that has received a judicial or administrative subpoena,
- 6 summons, or any other request for the production of its records is
- 7 entitled to receive from the requesting party reimbursement for the
- 8 reasonable cost of producing these records, only when the cost of
- 9 producing the records exceeds twenty-five dollars.
- 10 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 31.12 RCW
- 11 to read as follows:
- 12 A credit union that has received a judicial or administrative
- 13 subpoena, summons, or any other request for the production of its
- 14 records is entitled to receive from the requesting party reimbursement
- 15 for the reasonable cost of producing these records, only when the cost
- 16 of producing the records exceeds twenty-five dollars. For the purposes
- 17 of this section the term credit union includes a state chartered or
- 18 nationally chartered credit union.
- 19 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 32.04 RCW
- 20 to read as follows:
- 21 A mutual savings bank that has received a judicial or
- 22 administrative subpoena, summons, or any other request for the
- 23 production of its records is entitled to receive from the requesting
- 24 party reimbursement for the reasonable cost of producing these records,
- 25 only when the cost of producing the records exceeds twenty-five
- 26 dollars. For the purposes of this section the term mutual savings bank
- 27 includes a state chartered or nationally chartered mutual savings bank.

- 7 only when the cost of producing the records exceeds twenty-five
- 8 dollars. For the purposes of this section the term savings and loan
- 9 association includes a state chartered or nationally chartered savings
- 10 and loan association.
