- 1 AN ACT Relating to aircraft maintenance vocational training;
- 2 creating a new section; making appropriations; and declaring an
- 3 emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that the creation
- 6 of new jobs is crucial to the economic well-being of the state and its
- 7 residents. As several commercial airlines are considering establishing
- 8 major aircraft maintenance facilities in the state, it is important for
- 9 the state to demonstrate the ability to provide a skilled work force
- 10 with the technical skills essential for such a facility. Providing
- 11 additional state assistance to vocational training programs on aircraft
- 12 maintenance will ease job displacement in the state and offer an
- 13 incentive for economic development.

- 1 <u>NEW SECTION.</u> **Sec. 2.** (1) The sum of five hundred thousand
- 2 dollars for the biennium ending June 30, 1993, and the sum of one
- 3 million dollars for the biennium ending June 30, 1995, or so much
- 4 thereof as may be necessary, are appropriated from the general fund to
- 5 the department of trade and economic development for allocation to a
- 6 state technical or community college for a vocational training program
- 7 on the maintenance of commercial aircraft. Moneys allocated under this
- 8 section shall not be used to replace or supplant existing funding.
- 9 (2) The department of trade and economic development shall not
- 10 expend any portion of the appropriations in this section for
- 11 administrative expenses or overhead.
- 12 (3) The appropriations in this section are contingent on the
- 13 establishment by a commercial airline of a new facility in this state
- 14 for the maintenance of commercial aircraft. If such a facility is not
- 15 established, the appropriations in this section shall lapse.
- 16 <u>NEW SECTION.</u> **Sec. 3.** This act is necessary for the immediate
- 17 preservation of the public peace, health, or safety, or support of the
- 18 state government and its existing public institutions, and shall take
- 19 effect immediately.
