SENATE JOINT MEMORIAL 8028

State of Washington 52nd Legislature 1992 Regular Session

- 1 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 2 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 3 UNITED STATES, IN CONGRESS ASSEMBLED:
- 4 We, your Memorialists, the Senate and House of Representatives of
- 5 the State of Washington, in legislative session assembled, respectfully
- 6 represent and petition as follows:
- WHEREAS, With each passing year this Nation becomes deeply in debt
- 8 as its expenditures grossly and repeatedly exceed available revenues so
- 9 that the public debt now exceeds three trillion dollars; and
- 10 WHEREAS, Attempts to limit spending, including impoundment of funds
- 11 by the President of the United States, have resulted in strenuous
- 12 assertions that the responsibility for appropriations is the
- 13 constitutional duty of the Congress; and
- 14 WHEREAS, The annual Federal budget repeatedly demonstrates the
- 15 unwillingness or inability of both the legislative and executive

- 1 branches of the Federal government to curtail spending to conform to
- 2 available revenues; and
- 3 WHEREAS, The unified budget does not reflect actual spending
- 4 because of the exclusion of special outlays which are not in the
- 5 budget; and
- 6 WHEREAS, Knowledgeable planning and fiscal prudence require that
- 7 the budget reflect all Federal spending and that the budget be in
- 8 balance; and
- 9 WHEREAS, Believing that fiscal irresponsibility at the Federal
- 10 level is one of the greatest economic threats which faces our Nation,
- 11 we firmly believe that constitutional restraint is necessary to bring
- 12 the fiscal discipline needed to reverse this trend; and
- WHEREAS, Under Article V of the Constitution of the United States,
- 14 amendments to the Federal Constitution may be proposed by the Congress
- 15 whenever two-thirds of both Houses deem it necessary, or on the
- 16 application of the Legislatures of two-thirds of the several States and
- 17 the Congress shall call a constitutional convention for the purpose of
- 18 proposing amendments;
- NOW, THEREFORE, Your Memorialists, a majority of all members of the
- 20 two houses, voting separately, concurring herein, petition the Congress
- 21 of the United States of America to adopt an amendment to the
- 22 Constitution of the United States, for submission to the states for
- 23 ratification, requiring, with certain exceptions, that for each fiscal
- 24 year the President of the United States submit and the Congress of the
- 25 United States adopt a balanced federal budget; or, in the alternative,
- 26 that pursuant to Article V of the Constitution of the United States,
- 27 the Legislature of the State of Washington makes application to the
- 28 Congress of the United States of America to call a convention for the
- 29 specific and exclusive purpose of proposing an amendment to the
- 30 Constitution of the United States, for submission to the states for

- 1 ratification, requiring, with certain exceptions, that for each fiscal
- 2 year the President of the United States submit and the Congress of the
- 3 United States adopt a balanced federal budget. If Congress adopts,
- 4 within sixty days after the Legislatures of two-thirds of the States
- 5 have made application for such convention, an amendment to the
- 6 Constitution of the United States similar in subject matter to that
- 7 contained in this resolution, then this application for a convention
- 8 shall no longer be of any force or effect.
- 9 This application and request is null and void, rescinded, and of no
- 10 effect in the event that such convention is not limited to such
- 11 specific and exclusive purpose.
- 12 This application by this Legislature constitutes a continuing
- 13 application in accordance with Article V of the Constitution of the
- 14 United States until at least two-thirds of the Legislatures of the
- 15 several States have made application for a similar convention pursuant
- 16 to Article V or the Congress has proposed an amendment to the
- 17 Constitution of the United States similar in subject matter to that
- 18 contained in this Memorial.
- 19 BE IT RESOLVED, That copies of this Memorial be immediately
- 20 transmitted to the President of the United States Senate, the Speaker
- 21 of the House of Representatives, to each member of Congress from the
- 22 State of Washington, and to the presiding officer of each house of each
- 23 state legislature in the United States.
