21 offender into the juvenile offender basic training camp program, the  
22 court shall commit the offender to the department for the offender's  
23 standard range disposition, and shall order the department to place the  
24 offender in the training camp program unless the department determines  
25 that the juvenile is ineligible for the program due to health problems  
26 as provided in section 727 of this act."

21 the standard range and order the department to place the juvenile in  
22 the program unless the offender's health would be jeopardized.
