7 RCW to read as follows:

8 No city may enact or maintain an ordinance, development regulation,  
9 zoning regulation or official control, policy, or administrative  
10 practice which treats the siting of a structure or housing unit  
11 occupied by persons with handicaps differently than a structure or  
12 housing unit occupied by families or other unrelated individuals. As  
13 used in this section, "handicaps" are as defined in the federal fair  
14 housing amendments act of 1988 (42 U.S.C. Sec. 3602).

15 NEW SECTION. **Sec. 18.** A new section is added to chapter 35A.63  
16 RCW to read as follows:

17 No city may enact or maintain an ordinance, development regulation,  
18 zoning regulation or official control, policy, or administrative  
19 practice which treats the siting of a structure or housing unit  
20 occupied by persons with handicaps differently than a structure or  
21 housing unit occupied by families or other unrelated individuals. As  
22 used in this section, "handicaps" are as defined in the federal fair  
23 housing amendments act of 1988 (42 U.S.C. Sec. 3602).

24 NEW SECTION. **Sec. 19.** A new section is added to chapter 36.70 RCW  
25 to read as follows:

26 No county may enact or maintain an ordinance, development  
27 regulation, zoning regulation or official control, policy, or  
28 administrative practice which treats the siting of a structure or  
29 housing unit occupied by persons with handicaps differently than a  
30 structure or housing unit occupied by families or other unrelated  
31 individuals. As used in this section, "handicaps" are as defined in  
32 the federal fair housing amendments act of 1988 (42 U.S.C. Sec. 3602).

1        NEW SECTION.    **Sec. 20.**    A new section is added to chapter 36.70A  
2 RCW to read as follows:

3        No county or city that plans or elects to plan under this chapter  
4 may enact or maintain an ordinance, development regulation, zoning  
5 regulation or official control, policy, or administrative practice  
6 which treats the siting of a structure or housing unit occupied by  
7 persons with handicaps differently than a structure or housing unit  
8 occupied by families or other unrelated individuals. As used in this  
9 section, "handicaps" are as defined in the federal fair housing  
10 amendments act of 1988 (42 U.S.C. Sec. 3602)."

11        Renumber the remaining sections consecutively and correct internal  
12 references accordingly.
