22 ending on May 7, 1975, and who qualify as a resident student under RCW
23 28B.15.012, and who enrolled in state institutions of higher education
24 on or before May 7, 1990. This section shall expire June 30, (~~(1995))~~

26 **Sec. 2.** RCW 28B.15.628 and 1993 sp.s. c 18 s 25 are each amended
27 to read as follows:

28 Subject to the limitations of RCW 28B.15.910, the governing boards
29 of the state universities, the regional universities, The Evergreen
30 State College, and the community colleges may exempt veterans of the
31 Persian Gulf combat zone from all or a portion of increases in tuition
32 and fees that occur (~~during and after their period of service. In~~
33 ~~such cases, the veteran shall not be required to pay more than the~~
34 ~~total amount of tuition and fees established for)) after the 1990-91
35 academic year, if the veteran could have qualified as a Washington~~

1 resident student under RCW 28B.15.012(2), had he or she been enrolled
2 as a student on August 1, 1990, and if the veteran's adjusted gross
3 family income as most recently reported to the internal revenue service
4 does not exceed Washington state's median family income as established
5 by the federal bureau of the census. For the purposes of this section,
6 "a veteran of the Persian Gulf combat zone" means a person who during
7 any portion of calendar year 1991, served in active federal service as
8 a member of the armed military or naval forces of the United States in
9 a combat zone as designated by the president of the United States by
10 executive order.
