5 Strike everything after the enacting clause and insert the
6 following:

7 "**Sec. 1.** RCW 79.64.020 and 1985 c 57 s 80 are each amended to read
8 as follows:

9 A resource management cost account in the state treasury is hereby
10 created to be used solely for the purpose of defraying the costs and
11 expenses necessarily incurred by the department in managing and
12 administering public lands and the making and administering of leases,
13 sales, contracts, licenses, permits, easements, and rights of way as
14 authorized under the provisions of this title. Appropriations from the
15 account to the department shall be expended for no other purposes.
16 Funds in the account may be appropriated or transferred by the
17 legislature for the benefit of all of the trusts from which the funds
18 were derived.

19 **Sec. 2.** RCW 79.64.030 and 1988 c 70 s 4 are each amended to read
20 as follows:

21 Funds in the account derived from the gross proceeds of leases,
22 sales, contracts, licenses, permits, easements, and rights of way
23 issued by the department and affecting school lands, university lands,
24 agricultural college lands, scientific school lands, normal school
25 lands, capitol building lands, or institutional lands shall be pooled
26 and expended by the department solely for the purpose of defraying the
27 costs and expenses necessarily incurred in managing and administering
28 (~~(public lands of the same trust: PROVIDED, That)~~) all of the trust
29 lands enumerated in this section. Such funds may be used for similar
30 costs and expenses in managing and administering other lands managed by
31 the department(~~(: PROVIDED FURTHER,)~~) provided that such expenditures
32 that have been or may be made on such other lands shall be repaid to
33 the resource management cost account together with interest at a rate
34 determined by the board of natural resources.

1 An accounting shall be made annually of the accrued expenditures
2 (~~as regards each~~) from the pooled trust funds in the account. In the
3 event the accounting determines that expenditures have been made from
4 moneys derived from (~~one category of~~) trust lands for the benefit of
5 (~~another trust or~~) other lands, such expenditure shall be considered
6 a debt (~~against the trust benefited~~) and (~~shall be considered~~) an
7 encumbrance against the property (~~of the trust or trust funds~~)
8 benefited, including property held under chapter 76.12 RCW. The
9 results of the accounting shall be reported to the legislature at the
10 next regular session. The state treasurer is authorized, upon request
11 of the department, to transfer funds between the forest development
12 account and the resource management cost account solely for purpose of
13 repaying loans pursuant to this section.

14 NEW SECTION. **Sec. 3.** This act shall take effect July 1, 1994."
