26 NEW SECTION. Sec. 8. Recognizing that the Intermodal Surface
27 Transportation Efficiency Act of 1991 establishes a national "Scenic
28 Byways" grant program and a new apportionment program called
29 "Transportation Enhancement Activities," the department of
30 transportation shall place high priority on obtaining funds from those
31 sources for further development of a scenic and recreational highways
32 program, including highway heritage projects on the designated scenic
33 and recreational highway system. The department shall consider the use
34 of the designated system by bicyclists and pedestrians in connection
35 with nonmotorized routes in the state trail plan, and the state bicycle
36 plan which are also eligible for ISTEPA funding. Appropriate signage
37 may be used at intersections of nonmotorized and motorized systems to

1 demonstrate the access, location, and the interconnectivity of various
2 modes of travel for transportation and recreation.

3 NEW SECTION. **Sec. 9.** A new section is added to chapter 47.39 RCW
4 to read as follows:

5 In developing the scenic and recreational highways program, the
6 department shall consult with the department of trade and economic
7 development, the department of community development, the department of
8 natural resources, the parks and recreation commission, affected
9 cities, towns, and counties, regional transportation planning
10 organizations, state-wide bicycling organizations, and other interested
11 parties. The scenic and recreational highways program may identify
12 entire highway loops or similar tourist routes that could be developed
13 to promote tourist activity and provide concurrent economic growth
14 while protecting the scenic and recreational quality surrounding state
15 highways.

16 **Sec. 10.** RCW 47.42.020 and 1991 c 94 s 1 are each amended to read
17 as follows:

18 The definitions set forth in this section apply throughout this
19 chapter.

20 (1) "Department" means the Washington state department of
21 transportation.

22 (2) "Erect" means to construct, build, raise, assemble, place,
23 affix, attach, create, paint, draw, or in any other way bring into
24 being or establish.

25 (3) "Interstate system" means any state highway which is or does
26 become part of the national system of interstate and defense highways
27 as described in section 103(d) of title 23, United States Code.

28 (4) "Maintain" means to allow to exist.

29 (5) "Person" means this state or any public or private corporation,
30 firm, partnership, association, as well as any individual or
31 individuals.

32 (6) "Primary system" means any state highway which is or does
33 become part of the federal-aid primary system as described in section
34 103(b) of title 23, United States Code.

35 (7) "Scenic system" means (a) any state highway within any public
36 park, federal forest area, public beach, public recreation area, or
37 national monument, (b) any state highway or portion thereof outside the

1 boundaries of any incorporated city or town designated by the
2 legislature as a part of the scenic system, or (c) any state highway or
3 portion thereof outside the boundaries of any incorporated city or town
4 designated by the legislature as a part of the scenic and recreational
5 highway system except for the sections of highways specifically
6 excluded in RCW 47.42.025 or located within areas zoned by the
7 governing county for predominantly commercial and industrial uses, and
8 having development visible to the highway, as determined by the
9 department.

10 (8) "Sign" means any outdoor sign, display, device, figure,
11 painting, drawing, message, placard, poster, billboard, or other thing
12 that is designed, intended, or used to advertise or inform, any part of
13 the advertising or informative contents of which is visible from any
14 place on the main-traveled way of the interstate system or other state
15 highway.

16 (9) "Commercial and industrial areas" means any area zoned
17 commercial or industrial by a county or municipal code, or if unzoned
18 or zoned for general uses by a county or municipal code, that area
19 occupied by three or more separate and distinct commercial or
20 industrial activities, or any combination thereof, within a space of
21 five hundred feet and the area within five hundred feet of such
22 activities on both sides of the highway. The area shall be measured
23 from the outer edges of the regularly used buildings, parking lots, or
24 storage or processing areas of the commercial or industrial activity
25 and not from the property lines of the parcels upon which the
26 activities are located. Measurements shall be along or parallel to the
27 edge of the main traveled way of the highway. The following shall not
28 be considered commercial or industrial activities:

29 (a) Agricultural, forestry, grazing, farming, and related
30 activities, including, but not limited to, wayside fresh produce
31 stands;

32 (b) Transient or temporary activities;

33 (c) Railroad tracks and minor sidings;

34 (d) Signs;

35 (e) Activities more than six hundred and sixty feet from the
36 nearest edge of the right of way;

37 (f) Activities conducted in a building principally used as a
38 residence.

1 If any commercial or industrial activity that has been used in defining
2 or delineating an unzoned area ceases to operate for a period of six
3 continuous months, any signs located within the former unzoned area
4 become nonconforming and shall not be maintained by any person.

5 (10) "Roadside area information panel or display" means a panel or
6 display located so as not to be readable from the main traveled way,
7 erected in a safety rest area, scenic overlook, or similar roadside
8 area, for providing motorists with information in the specific interest
9 of the traveling public.

10 (11) "Temporary agricultural directional sign" means a sign on
11 private property adjacent to state highway right of way to provide
12 directional information to places of business offering for sale
13 seasonal agricultural products on the property where the sale is taking
14 place.

15 **Sec. 11.** RCW 47.42.100 and 1974 ex.s. c 154 s 3 are each amended
16 to read as follows:

17 (1) No sign lawfully erected in a protected area as defined by
18 section 2, chapter 96, Laws of 1961 (before the amendment thereof),
19 prior to March 11, 1961, within a commercial or industrial zone within
20 the boundaries of any city or town, as such boundaries existed on
21 September 21, 1959, wherein the use of real property adjacent to the
22 interstate system is subject to municipal regulation or control but
23 which does not comply with the provisions of this chapter or any
24 regulations promulgated hereunder, shall be maintained by any person
25 after March 11, 1965.

26 (2) No sign lawfully erected in a protected area as defined by
27 section 2, chapter 96, Laws of 1961 (before the amendment thereof),
28 prior to March 11, 1961, other than within a commercial or industrial
29 zone within the boundaries of a city or town as such boundaries existed
30 on September 21, 1959, wherein the use of real property adjacent to the
31 interstate system is subject to municipal regulation or control but
32 which does not comply with the provisions of this chapter or any
33 regulations promulgated hereunder, shall be maintained by any person
34 after three years from March 11, 1961.

35 (3) No sign lawfully erected in a scenic area as defined by section
36 2, chapter 96, Laws of 1961 (before the amendment thereof), prior to
37 the effective date of the designation of such area as a scenic area

1 shall be maintained by any person after three years from the effective
2 date of the designation of any such area as a scenic area.

3 (4) No sign visible from the main traveled way of the interstate
4 system, the primary system (other than type 3 signs along any portion
5 of the primary system within an incorporated city or town or within a
6 commercial or industrial area), or the scenic system which was there
7 lawfully maintained immediately prior to May 10, 1971, but which does
8 not comply with the provisions of chapter 47.42 RCW as now or hereafter
9 amended, shall be maintained by any person (a) after three years from
10 May 10, 1971, or (b) with respect to any highway hereafter designated
11 by the legislature as a part of the scenic system, after three years
12 from the effective date of the designation. Signs located in areas
13 zoned by the governing county for predominantly commercial or
14 industrial uses, that do not have development visible to the highway,
15 as determined by the department, and that were lawfully installed after
16 May 10, 1971, visible to any highway now or hereafter designated by the
17 legislature as part of the scenic system, shall be allowed to be
18 maintained.

19 **Sec. 12.** RCW 47.42.140 and 1992 c 26 s 3 are each amended to read
20 as follows:

21 The following portions of state highways are designated as a part
22 of the scenic system:

23 (1) State route number 2 beginning at the crossing of Woods creek

25 way of Stevens pass to a junction with state route number 97 in the
