32 (a) Provide temporary emergency mortgage <u>loans</u> or rental assistance 33 <u>grants or</u> loans on behalf of dislocated forest products workers in 34 timber impact areas who are unable to make ((<del>current</del>)) mortgage, 35 <u>property tax</u>, or rental payments on their permanent residences and are

- The department shall carry out the following duties:

- 19 (3) Develop and adopt the necessary rules and procedures for 20 implementation of the program and for dispersal of program funds to 21 eligible organizations;
- 22 (4) Establish the interest rate for repayment of loans at two 23 percent below the market rate;
- (5) Work with lending institutions and social service providers in the eligible communities to assure that all eligible persons are informed about the program;
