1 All machine guns and assault weapons, or parts thereof, illegally  
2 held or illegally possessed are hereby declared to be contraband, and  
3 it shall be the duty of all peace officers, and/or any officer or  
4 member of the armed forces of the United States or the state of  
5 Washington, to seize said machine gun or assault weapon, or parts  
6 thereof, wherever and whenever found."

15 county of the person's residence within ninety days of the effective  
16 date of this section shall be immune from prosecution for the  
17 possession of that assault weapon. The police chief or sheriff shall  
18 make a determination of the fair market value of any assault weapon  
19 surrendered within ninety days of the effective date of this section  
20 and shall pay the owner of any assault weapon so surrendered the fair  
21 market value of the assault weapon or two hundred dollars, whichever is  
22 less."
