- (11) To accept gifts, grants, conveyances, bequests, and devises, 1 of real or personal property, or both, in trust or otherwise, and sell, 2 lease, exchange, invest, or expend these donations or the proceeds, 3 4 rents, profits, and income from the donations except as limited by the donor's terms. The commission shall adopt rules to govern and protect 5 the receipt and expenditure of the proceeds, rents, profits, and income 6 7 of all such gifts, grants, conveyances, bequests, and devises. The authority to make expenditures granted by this subsection includes the 8 9 authority to make expenditures to provide scholarships or financial 10 assistance to persons as defined in RCW 1.16.080 or entities associated with the apple industry, but is not limited to the authority to make 11 expenditures for such a purpose; and 12 (12) To engage in appropriate fund-raising activities for the 13 purpose of supporting the activities of the commission authorized by 14
