No additional payments are required for service credit 23 described in this subsection if already established under this chapter; 24 and
- 25 (c) Establish service credit for the initial period of employment 26 not to exceed six months, prior to establishing membership under 27 chapter 41.44 RCW, upon payment in full by the member of the total employer's contribution to the benefit account fund of the public 28 29 employees' retirement system that would have been made under this 30 chapter when the initial service was rendered. The payment shall be based on the first month's compensation earnable as a member of the 31 state-wide city employees' retirement system and as defined in RCW 32 33 41.44.030(13). However, a person who has established service credit under RCW $41.40.010((\frac{11}{(11)}))(13)$ (c) or (d) shall not establish 34 35 additional credit under this subsection nor may anyone who establishes

- credit under this subsection establish any additional credit under RCW $41.40.010((\frac{11}{11}))(13)$ (c) or (d). No additional payments are required for service credit described in this subsection if already established under this chapter.
- 5 (2)(a) In the case of a member of the public employees' retirement 5 system who is employed by an employer on July 26, 1987, the written 7 election required by subsection (1) of this section must be filed and 8 the payments required by subsection (1)(b) and (c) of this section must 9 be completed ((in full within one year after July 26, 1987)) by 10 December 31, 1993.
