- (1) "Emergency management" or "comprehensive emergency management" 10 means the preparation for and the carrying out of all emergency 11 12 functions, other than functions for which the military forces are primarily responsible, to mitigate, prepare for, respond to, and 13 recover from emergencies and disasters, and to aid victims suffering 14 15 from injury or damage, resulting from disasters caused by all hazards, 16 whether natural or man-made, and to provide support for search and 17 rescue operations for persons and property in distress. 18 "emergency management" or "comprehensive emergency management" does not 19 mean preparation for emergency evacuation or relocation of residents in 20 anticipation of nuclear attack.
- (2) "Local organization for emergency services or management" means an organization created in accordance with the provisions of this chapter by state or local authority to perform local emergency management functions.
 - (3) "Political subdivision" means any county, city or town.
- (4) "Emergency worker" means any person who is registered with a 26 27 local emergency management organization or the department of community development and holds an identification card issued by the local 28 29 emergency management director or the department of community 30 development for the purpose of engaging in authorized emergency management activities, is an architect registered under chapter 18.08 31 32 RCW or a professional engineer registered under chapter 18.43 RCW, or is an employee of the state of Washington or any political subdivision 33 34 thereof who is called upon to perform emergency management activities.

- 1 (5) "Injury" as used in this chapter shall mean and include 2 accidental injuries and/or occupational diseases arising out of 3 emergency management activities.
- 4 (6) "Emergency or disaster" as used in this chapter shall mean an event or set of circumstances which: (a) Demands immediate action to preserve public health, protect life, protect public property, or to provide relief to any stricken community overtaken by such occurrences, or (b) reaches such a dimension or degree of destructiveness as to warrant the governor declaring a state of emergency pursuant to RCW 43.06.010.
- (7) "Search and rescue" means the acts of searching for, rescuing, or recovering by means of ground, marine, or air activity any person who becomes lost, injured, or is killed while outdoors or as a result of a natural or man-made disaster, including instances involving searches for downed aircraft when ground personnel are used. Nothing in this section shall affect appropriate activity by the department of transportation under chapter 47.68 RCW.
- 18 (8) "Executive head" and "executive heads" means the county
 19 executive in those charter counties with an elective office of county
 20 executive, however designated, and, in the case of other counties, the
 21 county legislative authority. In the case of cities and towns, it
 22 means the mayor.
 - (9) "Director" means the director of community development.
- 24 (10) "Local director" means the director of a local organization of 25 emergency management or emergency services.
- 26 (11) "Department" means the department of community development.
- 27 (12) "Damage to property" includes, without limitation, any 28 business interruption or other economic losses that may result from 29 damage to, or the destruction or condemnation of, any real property."
