- 8 (1) The legislative body of any city with a population of at least

- 10 county east of the crest of the Cascade mountains with a population of
- 11 at least fifty thousand but less than sixty thousand is authorized to
- 12 levy and collect a special excise tax not to exceed three percent on
- 13 the sale of or charge made for the furnishing of lodging by a hotel,
- 14 rooming house, tourist court, motel, trailer camp, and the granting of
- 15 any similar license to use real property, as distinguished from the
- 16 renting or leasing of real property. For the purposes of this tax, it
- 17 shall be presumed that the occupancy of real property for a continuous
- 18 period of one month or more constitutes a rental or lease of real
- 19 property and not a mere license to use or to enjoy the same.
- 20 (2) The tax authorized in subsection (1) of this section is in
- 21 addition to any other tax authorized by law.
- 22 (3) Any seller, as defined in RCW 82.08.010, who is required to
- 23 collect any tax under this section shall pay over such tax to the
- 24 county as provided in RCW 67.28.200. The deduction from state taxes
- 25 under RCW 67.28.190 does not apply to the tax imposed under this
- 26 section.
- 27 (4) All taxes levied and collected under this section shall be
- 28 credited to a special fund in the treasury of the county. Such taxes
- 29 shall only be used for tourism promotion.
- 30 Sec. 3. RCW 67.28.200 and 1991 c 331 s 2 are each amended to read
- 31 as follows:
- 32 The legislative body of any county or city may establish reasonable
- 33 exemptions and may adopt such reasonable rules and regulations as may
- 34 be necessary for the levy and collection of the taxes authorized ((by
- 35 RCW 67.28.180, 67.28.182, and 67.28.230 through 67.28.250, and

- 1 67.28.260)) under this chapter. The department of revenue shall
- 2 perform the collection of such taxes on behalf of such county or city
- 3 at no cost to such county or city."
