State of Washington 53rd Legislature 1993 Regular Session

Read first time 02/19/93. Referred to Committee on Capital Budget.

1 AN ACT Relating to coastal economic recovery; creating new
2 sections; and making appropriations.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** The legislature finds that it is imperative
5 to assist coastal residents and communities whose jobs and economy have
6 been impacted by implementation of the federal endangered species act
7 and a decline in commercial salmon fishing to make the transition to an
8 economy that includes strengthened tourism, outdoor recreation, and an
9 improved recreation and commercial fishery. The legislature further
10 finds that social and education needs of coastal residents are
11 increased as a result of the economic dislocation, and must be
12 reorganized as part of the economic transition of coastal residents and
13 communities.
