1 AN ACT Relating to transportation appropriations; amending 1993  
2 sp.s. c 23 ss 1, 2, 4, 5, 6, 7, 8, 9, 10, 11,12, 16, 21, 22, 23, 25,  
3 26, 27, 29, 31,32, 34, 35, 37, 39, 40, and 47 (uncodified); adding new  
4 sections to 1993 sp.s. c 23; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** 1993 sp.s. c 23 s 1 (uncodified) is amended to read as

8 The transportation budget of the state is hereby adopted and,  
9 subject to the provisions hereinafter set forth, the several amounts  
10 hereinafter specified, or as much thereof as may be necessary to  
11 accomplish the purposes designated, are hereby appropriated from the  
12 several accounts and funds hereinafter named to the designated state  
13 agencies and offices for salaries, wages, and other expenses, for  
14 capital projects, and for other specified purposes, including the  
15 payment of any final judgments arising out of such activities, for the  
16 period ending June 30, 1995.

17 appropriations in this section are subject to the following conditions  
18 and limitations:

19 (1) The motor vehicle fund--state appropriation includes a maximum  
20 of \$50,800,000 in proceeds from the sale of bonds authorized by RCW  
21 47.10.790 and 47.10.801. However, the transportation commission may  
22 authorize the use of current revenues available to the department of  
23 transportation in lieu of bond proceeds for any part of the state  
24 appropriation.

25 (2) Should cash flow demands exceed the motor vehicle fund--federal  
26 appropriation, the motor vehicle fund--state appropriation is increased

 36 appropriations in this section are subject to the following conditions  
 37 and limitations:

1 (1) The motor vehicle fund--state appropriation includes  
2 \$32,800,000 in proceeds from the sale of bonds authorized by RCW  
3 47.10.790 and 47.10.801. However, the transportation commission may  
4 authorize the use of current revenues available to the department of  
5 transportation in lieu of bond proceeds for any part of the state  
6 appropriation.

7 (2) The motor vehicle fund--state appropriation includes proceeds
