## HOUSE JOINT MEMORIAL 4013

- 1 TO THE HONORABLE BILL CLINTON, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, The Washington State House of Representatives and Senate
- 9 recognize that implementation of federal endangered species legislation
- 10 has gravely and irreversibly impacted the coastal economies of Pacific
- 11 and Grays Harbor counties and parts of Jefferson and Clallam counties;
- 12 and
- 13 WHEREAS, The loss of timber-related jobs has created a further
- 14 erosion of jobs in coastal communities which presently do not have
- 15 alternative employment opportunities; and
- 16 WHEREAS, Hard-working families are losing their homes, automobiles,
- 17 and other possessions and are going without adequate food, critically
- 18 needed medical care, educational, and social services previously earned
- 19 with wages from their jobs; and
- 20 WHEREAS, The loss of sales tax, property tax, and other local
- 21 revenues by local coastal communities resulting from the devastating

- 1 economic dislocation is accompanied by a heavy additional burden placed
- 2 on public services provided by local police, prosecutors, public
- 3 health, and social service providers that manifestly precludes local
- 4 government from financing an economic recovery program; and
- 5 WHEREAS, In 1991 the federal government received an estimated one
- 6 hundred forty-three million dollars in general tax revenue, exclusive
- 7 of social security and unemployment insurance taxes, from Pacific and
- 8 Grays Harbor counties; and
- 9 WHEREAS, In 1991 the State of Washington received an estimated
- 10 seventy-seven million dollars in general fund taxes from the two-county
- 11 area; and
- 12 WHEREAS, Implementation of the Coastal Economic Recovery Action
- 13 Plan will provide jobs and improve the coastal economy so that at the
- 14 end of ten years the federal government tax revenues will increase from
- 15 one hundred forty-three million dollars a year to two hundred five
- 16 million dollars and the Washington State general fund revenues will
- 17 increase from seventy-seven million dollars a year to one hundred
- 18 thirteen million dollars over the ten-year period; and
- 19 WHEREAS, The millions of dollars monthly spent by the federal and
- 20 state government for public assistance, unemployment compensation,
- 21 medical assistance, food, retraining, and other social service programs
- 22 can be sharply reduced through implementation of the coastal economy
- 23 which emphasizes tourism, outdoor recreation, and commercial and sports
- 24 fishing;
- NOW, THEREFORE, Your Memorialists respectfully pray that the
- 26 federal government invest, along with the State of Washington, in a
- 27 Coastal Economic Recovery Plan by funding the following elements of the
- 28 plan:
- 29 (1) Habitat restoration jobs, including Olympic peninsula, Grays
- 30 Harbor and Willapa Bay drainages. The primary beneficiaries of the
- 31 work will be wild stocks of salmon: Fifty million dollars;
- 32 (2) Federal share of new coastal hatcheries including wild stock
- 33 supplementation facilities: Seventeen million five hundred thousand
- 34 dollars;
- 35 (3) Federal share of coastal tourism infrastructure facilities:
- 36 Twelve million dollars;
- 37 (4) Federal funding of educational facilities at Grays Harbor
- 38 College for Dislocated Timber Workers: Five million dollars; and

- 1 (5) Federal share of coastal transportation facilities for tourism 2 and outdoor recreation: Ten million dollars.
- BE IT RESOLVED, That copies of this Memorial be immediately transmitted to the Honorable Bill Clinton, President of the United States, the President of the Senate, the Speaker of the House of Representatives, and each member of Congress from the State of Washington.
