1            AN ACT Relating to the capital budget; amending 1991 c 14 s 21  
2 (uncodified); amending 1992 c 233 s 12 (uncodified); adding a new  
3 section to chapter 233, Laws of 1992 (uncodified); and declaring an  
4 emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6            NEW SECTION.    **Sec. 1.** A new section is added to chapter 233, Laws  
7 of 1992 (uncodified) to read as follows:

8            **FOR THE DEPARTMENT OF GENERAL ADMINISTRATION**

9            The department of general administration may enter into a financial  
10 contract in the principal amount of \$24,800,000 plus financing costs  
11 and required reserves pursuant to chapter 39.94 RCW. This amount is  
12 for the acquisition of land and a building located in Yakima, and for  
13 development of a Yakima Government Service Center that will be used for  
14 state agencies.

15            **Sec. 2.** 1991 c 14 s 21 (uncodified) is amended to read as follows:

16            **FOR THE DEPARTMENT OF TRADE AND ECONOMIC DEVELOPMENT**

1 (1) Community economic revitalization board (86-1-001)  
 2 \$2,000,000 of the state building and construction account  
 3 appropriation and the entire public facility construction loan  
 4 revolving account appropriation in this subsection are provided solely  
 5 for communities defined as timber-dependent under chapter 314, Laws of  
 6 1991 (Engrossed Substitute House Bill No. 1341). In allocating these  
 7 funds, the community economic revitalization board shall give priority  
 8 to communities experiencing high unemployment or high timber  
 9 unemployment.

 34 subsection is consistent with the purpose and intent of the original  
 35 appropriation in chapter 12, Laws of 1989 1st ex. sess.

 37 contribution of an equal amount of funds from nonstate sources.

23 construction of a cargo storage facility. This appropriation is  
24 subject to a favorable review by the department of a proposal prepared  
25 by the port of Grays Harbor describing how this project will: (a) Have  
26 a high probability of success using standard economic principles; (b)  
27 provide long-term economic benefits to the community; (c) include local  
28 participation; and (d) be consistent with the community's economic  
29 strategy and goals.

36 (7) Economic assessment study for timber-dependent ports

37 The appropriation in this subsection is provided solely for the  
38 department to contract for an economic assessment study of timber-  
39 dependent ports, limited to the ports of Grays Harbor, Port Angeles,  
40 and Longview. The study shall include the following: (a) A review and  
41 examination of the comparative advantage of each port's geographic and  
42 regional characteristics, and the characteristics of the three-port  
43 region, focusing on current and potential markets for exports and  
44 imports; (b) identification of specific diversification opportunities  
45 for the three-port region, including possibilities for expansion of  
46 nonlog export activities and opportunities; (c) identification of  
47 actions that each port can undertake to increase and develop business  
48 opportunities compatible with regional port resources and goals; (d)  
49 recommendations for long-term strategies for the three-port region  
50 focusing on market development, facilities development, and operations  
51 and financial requirements; (e) strategies to enhance cooperation in  
52 future development that would allow each of the three ports to

1 diversify in areas that would complement each other, including an  
 2 analysis of recent, present, or potential competition among the ports;  
 3 and (f) joint marketing strategies and joint capital facilities  
 4 planning.

4 made for any grant valued over fifty million dollars to a city or  
5 county for solid waste disposal facilities unless the following  
6 conditions are met:

7 (a) The city or county agrees to comply with all the terms of the  
8 grant contract between the city or county and the department of  
9 ecology;

10 (b) The city or county agrees to implement curbside collection of  
11 recyclable materials as prescribed in the grant contract; and

12 (c) The city or county does not begin actual construction of the  
13 solid waste disposal facility until it has obtained a permit for  
14 prevention of significant deterioration as required by the federal  
15 clean air act.

24 (5) Water quality account (86-5-007)

25 The appropriations in this subsection are subject to the following  
26 conditions and limitations:

27 (a) In awarding grants, extending grant payments, or making loans  
28 from these appropriations for facilities that discharge directly into  
29 marine waters, the department shall:

30 (i) Give first priority to secondary wastewater treatment  
31 facilities that are mandated by both federal and state law;

32 (ii) Give second priority to projects that reduce combined sewer  
33 overflows; and

34 (iii) Encourage economies that are derived from any simultaneous  
35 projects that achieve the purposes of both (a) and (b) of this  
36 subsection.

37 (b) The following limitations shall apply to the department's total  
38 distribution of funds appropriated under this section:

39 (i) Not more than fifty percent for water pollution control  
40 facilities that discharge directly into marine waters;

41 (ii) Not more than twenty percent for water pollution control  
42 activities that prevent or mitigate pollution of underground waters and  
43 facilities that protect federally designated sole source aquifers with  
44 at least two-thirds for the Spokane-Rathdrum Prairie aquifer;

45 (iii) Not more than ten percent for water pollution control  
46 activities that protect freshwater lakes and rivers including but not  
47 limited to Lake Chelan and the Yakima and Columbia rivers;

48 (iv) Not more than ten percent for activities that control nonpoint  
49 source water pollution;

50 (v) Ten percent and such sums as may be remaining from the  
51 categories specified in (i) through (iv) of this subsection for water  
52 pollution control activities or facilities as determined by the  
53 department.

54 (c) In determining compliance schedules for the greatest reasonable  
55 reduction of combined sewer overflows, the department shall consider

1 the amount of grant or loan moneys available to assist local  
2 governments in the planning, design, acquisition, construction, and  
3 improvement of combined sewer overflow facilities.

4 (d) \$330,000 of the water quality account appropriation is provided  
5 solely for the department to evaluate water quality, solid and  
6 hazardous waste, and toxics cleanup needs of the state. The amount  
7 provided in this subsection represents the water quality account share  
8 of funding the evaluation. The department shall include in the  
9 evaluation information regarding existing needs and recommendations on  
10 how to address those needs within existing state financial assistance  
11 programs. The department shall also evaluate long-range financial  
12 options which take into account local financial resources. The  
13 evaluation shall be done in coordination with the state agency  
14 coordinating council established in Engrossed Substitute House Bill No.  
15 1025 (Growth Management Strategies). If the bill is not enacted by  
16 July 31, 1991, the director of the department shall coordinate with the  
17 department of community development, the department of health, and the  
18 Puget Sound water quality authority as well as with other appropriate  
19 state and local agencies. By November 1, 1991, the department shall  
20 submit to the chairs of the house capital facilities and financing  
21 committee and the senate ways and means committee, a detailed work  
22 plan, budget, and schedule for completion of the evaluation.

42 \$300,000 of the new appropriation in this subsection is provided  
43 solely for a pilot grant program to address remedial actions involving  
44 the contamination of drinking water supplies from hazardous substances.  
45 The pilot grant program is limited to remedial action where a  
46 responsible party has not been identified or held responsible. The  
47 department may establish an appropriate local match requirement for the  
48 pilot grant program. The department shall report to the appropriate  
49 committees of the legislature regarding the state-wide need for  
50 programs to clean up drinking water supplies contaminated by hazardous  
51 substances. This report shall be consolidated into the evaluation  
52 required in ((subsection)) section 12(5)(d) ((of this section)),  
53 chapter 233, Laws of 1992.
