1            TO THE HONORABLE BILL CLINTON, PRESIDENT OF THE UNITED STATES, AND  
2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF  
3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE  
4 UNITED STATES, IN CONGRESS ASSEMBLED:

5            We, your Memorialists, the Senate and House of Representatives of  
6 the State of Washington, in legislative session assembled, respectfully  
7 represent and petition as follows:

8            WHEREAS, Owners of real property may not be aware of a United  
9 States Internal Revenue Service lien against the owner's property; and

10            WHEREAS, Without proper notice of such liens, property owners may  
11 be unduly or erroneously burdened when they attempt to sell property  
12 against which there is a federal tax lien;

13            NOW, THEREFORE, Your Memorialists respectfully pray that the United  
14 States Congress enact a law allowing states that impose notice  
15 requirement on state tax liens to impose a similar notice requirement  
16 on federal tax liens.

17            BE IT RESOLVED, That copies of this Memorial be immediately  
18 transmitted to the Honorable Bill Clinton, President of the United  
19 States, the President of the United States Senate, the Speaker of the

1 House of Representatives, and each member of Congress from the State of  
2 Washington.
