14 agreement between a buyer and a seller for the purchase and sale of
15 residential real property, the seller shall deliver to the buyer a
16 completed, signed, and dated real property transfer disclosure
17 statement. Within three business days, or as otherwise agreed to, of
18 receipt of the real property transfer disclosure statement, the buyer
19 shall have the right to exercise one of the following two options: (1)
20 Approving and accepting the real property transfer disclosure
21 statement; or (2) rescinding the agreement for the purchase and sale of
22 the property, which decision may be made by the buyer in the buyer's
23 sole discretion. If the buyer elects to rescind the agreement, the
24 buyer must deliver written notice of rescission to the seller within

3 amend the real property transfer disclosure statement, and deliver the
4 amendment to the buyer. No amendment shall be required, however, if
5 the seller takes whatever corrective action is necessary so that the
6 accuracy of the disclosure is restored, or the adverse change is
7 corrected, at least three business days prior to the closing date.
8 Unless the ((~~adverse change is corrected or repaired~~)) corrective
9 action is completed by the seller prior to the closing date, the buyer
10 shall have the right to exercise one of the following two options: (a)
11 Approving and accepting the amendment, or (b) rescinding the agreement

7 disclosure statement if the seller had no (~~personal~~) actual knowledge
8 of the error, inaccuracy, or omission. Unless the seller of
9 residential real property has actual knowledge of an error, inaccuracy,
10 or omission in a real property transfer disclosure statement, the
11 seller shall not be liable for such error, inaccuracy, or omission if
12 the disclosure was based on information provided by public agencies, or
13 by other persons providing information within the scope of their
14 professional license or expertise, including, but not limited to, a
15 report or opinion delivered by a land surveyor, title company, title
16 insurance company, structural inspector, pest inspector, licensed
17 engineer, or contractor.

18 (2) Any licensed real estate salesperson or broker involved in a
19 residential real property transaction is not liable for any error,
20 inaccuracy, or omission in the real property transfer disclosure
21 statement if the licensee had no (~~personal~~) actual knowledge of the
22 error, inaccuracy, or omission. Unless the salesperson or broker has
23 actual knowledge of an error, inaccuracy, or omission in a real
24 property transfer disclosure statement, the salesperson or broker shall
25 not be liable for such error, inaccuracy, or omission if the disclosure

27 persons providing information within the scope of their professional
28 license or expertise, including, but not limited to, a report or

35 extinguish or impair any rights or remedies of a buyer of real estate
36 against the seller or against any agent acting for the seller otherwise
37 existing pursuant to common law, statute, or contract; nor shall

1 anything in this chapter create any new right or remedy for a buyer of
2 residential real property other than the right of rescission exercised on
3 the basis and within the time limits provided in this chapter.
