24 NEW SECTION. **Sec. 3.** The following acts or parts of acts are each
25 repealed:

26 (1) RCW 48.22.070 and 1993 c 177 s 1 & 1992 c 209 s 2;

27 (2) RCW 48.22.071 and 1992 c 209 s 3; and

28 (3) RCW 48.22.072 and 1995 c . . . s 1 (section 1 of this act),
29 1993 c 177 s 2, & 1992 c 209 s 4.

30 NEW SECTION. **Sec. 4.** Section 3 of this act shall not be construed
31 as affecting any existing right acquired or liability or obligation
32 incurred under the sections amended or repealed in this act or under
33 any rule or order adopted under those sections, nor as affecting any

1 proceeding instituted under those sections.

2 NEW SECTION. **Sec. 5.** (1) Sections 1 and 2 of this act are
3 necessary for the immediate preservation of the public peace, health,
4 or safety, or support of the state government and its existing public
5 institutions, and shall take effect immediately.

6 (2) Sections 3 and 4 of this act shall take effect July 1, 1997."
