4 rehabilitation" strike all the matter through "development" on line
5 18, and insert "required under sections 3 through 5 of this act"

8 On page 3, after line 2 of the amendment, insert:

9 NEW SECTION. **Sec. 3.** Subject to the provisions of sections
10 2 and 6 of this act, the state auditor shall undertake a
11 comprehensive performance audit of the rehabilitation and job
12 support services provided by the department of social and health
13 services.

15 NEW SECTION. **Sec. 4.** Subject to the provisions of sections
16 2 and 6 of this act, the state auditor shall undertake a
17 comprehensive performance audit of the programs, services, and
18 activities operated by the superintendent of public instruction.

20 NEW SECTION. **Sec. 5.** Subject to the provisions of sections
21 2 and 6 of this act, the state auditor shall undertake a
22 comprehensive performance audit of the department of community,
23 trade, and economic development.

25 NEW SECTION. **Sec. 6.** If specific funding for the performance
26 audit specified under section 3 of this act, referencing section 3
27 of this act by bill number, is not provided by June 30, 1995, in
28 the omnibus appropriations act, section 3 of this act shall not be
29 implemented and is null and void unless specific funding for the
30 performance audit, referencing section 3 of this act, is provided

1 by June 30, 1996, in the omnibus appropriations act for the second
2 year of the biennium.

3 If specific funding for the performance audit specified under
4 section 4 of this act, referencing section 4 of this act by bill
5 number, is not provided by June 30, 1995, in the omnibus
6 appropriations act, section 4 of this act shall not be implemented
7 and is null and void unless specific funding for the performance
8 audit, referencing section 4 of this act, is provided by June 30,
9 1996, in the omnibus appropriations act for the second year of the
10 biennium.

11 If specific funding for the performance audit specified under
12 section 5 of this act, referencing section 5 of this act by bill
13 number, is not provided by June 30, 1995, in the omnibus
14 appropriations act, section 5 of this act shall not be implemented
15 and is null and void unless specific funding for the performance
16 audit, referencing section 5 of this act, is provided by June 30,
17 1996, in the omnibus appropriations act for the second year of the
18 biennium."

19
20 Renumber the remaining section consecutively and correct any
21 internal references accordingly.

EFFECT: Adds a null and void clause applicable to each of the
three separate performance audits required by the bill.
