- 1 AN ACT Relating to regular maintenance of marinas; adding a new
- 2 section to chapter 75.20 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. **Sec. 1.** The legislature finds that initial
- 5 construction of a marina and some maintenance activities change the
- 6 natural flow or bed of the salt or fresh water body in which the marina
- 7 is constructed. Because of this disturbance, it is appropriate that
- 8 plans for initial marina construction as well as some maintenance
- 9 activities undergo the hydraulic project review and approval process
- 10 established in chapter 75.20 RCW.
- 11 It is the intent of the legislature that after a marina has
- 12 received a hydraulic project approval and been constructed, a
- 13 renewable, five-year hydraulic project approval be issued, upon
- 14 request, for regular maintenance activities within the marina.
- 15 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 75.20 RCW
- 16 to read as follows:
- 17 (1) "Marina" means a public or private facility providing boat
- 18 moorage space, fuel, or commercial services. Commercial services

- 1 include but are not limited to overnight or live-aboard boating 2 accommodations.
- 3 (2) For a marina in existence on the effective date of this act or 4 a marina that has received a hydraulic project approval for its initial 5 construction, a renewable, five-year hydraulic project approval shall 6 be issued, upon request, for regular maintenance activities of the 7 marina.
- 8 (3) Upon construction of a new marina that has received hydraulic 9 project approval, a renewable, five-year hydraulic project approval 10 shall be issued, upon request, for regular maintenance activities of 11 the marina.
- 12 (4) For the purposes of this section, regular maintenance 13 activities are only those activities necessary to restore the marina to 14 the conditions approved in the initial hydraulic project approval. 15 These activities may include, but are not limited to, dredging, piling 16 replacement, and float replacement.
- 17 (5) The five-year permit must include a requirement that a 18 fourteen-day notice be given to the department before regular 19 maintenance activities begin.
