- 1 AN ACT Relating to rescinding a retirement allowance agreement;
- 2 amending RCW 41.40.188; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 41.40.188 and 1995 c 144 s 1 are each amended to read 5 as follows:
- 6 (1) Upon retirement for service as prescribed in RCW 41.40.180 or 7 retirement for disability under RCW 41.40.210 or 41.40.230, a member 8 shall elect to have the retirement allowance paid pursuant to one of 9 the following options calculated so as to be actuarially equivalent to 10 each other.
- 11 (a) Standard allowance. A member electing this option shall
- 12 receive a retirement allowance payable throughout such member's life.
- 13 However, if the retiree dies before the total of the retirement
- 14 allowance paid to such retiree equals the amount of such retiree's
- 15 accumulated contributions at the time of retirement, then the balance
- 16 shall be paid to the member's estate, or such person or persons, trust,
- 17 or organization as the retiree shall have nominated by written
- 18 designation duly executed and filed with the department; or if there be
- 19 no such designated person or persons still living at the time of the

- retiree's death, then to the surviving spouse; or if there be neither such designated person or persons still living at the time of death nor a surviving spouse, then to the retiree's legal representative.
- 4 (b) (i) The department shall adopt rules that allow a member to 5 select a retirement option that pays the member a reduced retirement allowance and upon death, such portion of the member's reduced 6 7 retirement allowance as the department by rule designates shall be 8 continued throughout the life of and paid to a person nominated by the 9 member by written designation duly executed and filed with the 10 department at the time of retirement. The options adopted by the department shall include, but are not limited to, a joint and one 11 hundred percent survivor option and a joint and fifty percent survivor 12 13 option.
- 14 (ii) Where a restraining order has been issued on behalf of a 15 retiree against the designated beneficiary of the survivor option, as selected by the retiree, and the court finds that the beneficiary has 16 violated that restraining order, the retiree, with permission of the 17 18 court, may rescind the beneficiary's entitlement to the survivor 19 benefit. The retiree is obligated to forward a certified copy of the court order to the department of retirement systems and the rescission 20 is effective upon receipt. The retiree's benefit will not increase by 21 result of the rescission and the retiree may not select another 22 23 beneficiary.
- (c) A member may elect to include the benefit provided under RCW 41.40.640 along with the retirement options available under this section. This retirement allowance option shall be calculated so as to be actuarially equivalent to the options offered under this subsection.
- (2) A member, if married, must provide the written consent of his or her spouse to the option selected under this section. If a member is married and both the member and the member's spouse do not give written consent to an option under this section, the department shall pay a joint and fifty percent survivor benefit calculated to be actuarially equivalent to the benefit options available under subsection (1) of this section.
- NEW SECTION. Sec. 2. Section 1 of this act is applicable to all current and future retirees.
