7 to read as follows:

8 Subject to the limitations of RCW 28B.15.910, the governing boards  
9 of the state universities, the regional universities, The Evergreen  
10 State College, and the community colleges may exempt the following  
11 nonresidents from paying all or a portion of the nonresident tuition  
12 fees differential:

13 (1) Any person who resides in the state of Washington and who holds  
14 a graduate service appointment designated as such by a public  
15 institution of higher education or is employed for an academic  
16 department in support of the instructional or research programs  
17 involving not less than twenty hours per week during the term such  
18 person shall hold such appointment.

19 (2) Any faculty member, classified staff member or administratively  
20 exempt employee holding not less than a half time appointment at an  
21 institution who resides in the state of Washington, and the dependent  
22 children and spouse of such persons.

23 (3) Active-duty military personnel stationed in the state of  
24 Washington.

25 (4) Any immigrant refugee and the spouse and dependent children of  
26 such refugee, if the refugee (a) is on parole status, or (b) has  
27 received an immigrant visa, or (c) has applied for United States  
28 citizenship.

29 ~~(5) ((Domestic exchange students participating in the program  
30 created under RCW 28B.15.725.~~

31 ~~(6))~~ Any dependent of a member of the United States congress  
32 representing the state of Washington."

4 On page 4, after line 23, insert the following:

5 "Sec. 4. RCW 28B.15.910 and 1993 sp.s. c 18 s 31 are each amended  
6 to read as follows:

7 (1) Except for revenue waived under programs listed in subsection  
8 (3) of this section, and unless otherwise expressly provided in the  
9 omnibus state appropriations act, the total amount of operating fees  
10 revenue waived, exempted, or reduced by a state university, a regional  
11 university, The Evergreen State College, or the community colleges as  
12 a whole, shall not exceed the percentage of total gross authorized  
13 operating fees revenue set forth below. As used in this section,  
14 "gross authorized operating fees revenue" means the estimated gross  
15 operating fees revenue as estimated under RCW 82.33.020 or as revised  
16 by the office of financial management, before granting any waivers.  
17 This limitation applies to all tuition waiver programs established  
18 before or after July 1, 1992.
