The department of 4 health shall reimburse the account from fees assessed under RCW 70.119A.115 by June 30, 1995.
- 6 (4) Except for unanticipated receipts under RCW 43.79.260 through 7 43.79.282, moneys in the state and local toxics control accounts may be 8 spent only after appropriation by statute.
- 9 (5) One percent of the moneys deposited into the state and local 10 toxics control accounts shall be allocated only for public participation grants to persons who may be adversely affected by a 11 release or threatened release of a hazardous substance and to not-for-12 13 profit public interest organizations. The primary purpose of these grants is to facilitate the participation by persons and organizations 14 15 in the investigation and remedying of releases or threatened releases of hazardous substances and to implement the state's solid and 16 17 hazardous waste management priorities. No grant may exceed sixty thousand dollars. Grants may be renewed annually. Moneys appropriated 18 19 for public participation from either account which are not expended at 20 the close of any biennium shall revert to the state toxics control 21 account.
- 22 (6) No moneys deposited into either the state or local toxics 23 control account may be used for solid waste incinerator feasibility 24 studies, construction, maintenance, or operation.
- 25 (7) The department shall adopt rules for grant or loan issuance and 26 performance.
- 27 **Sec. 904.** RCW 69.50.520 and 1997 c 451 s 2 and 1997 c 338 s 69 are 28 each reenacted and amended to read as follows:
- The violence reduction and drug enforcement account is created in the state treasury. All designated receipts from RCW 9.41.110(8),
- 31 66.24.210(4), 66.24.290(2), 69.50.505(h)(1), 82.08.150(5),
- 32 82.24.020(2), 82.64.020, and section 420, chapter 271, Laws of 1989
- 33 shall be deposited into the account. Expenditures from the account may
- 34 be used only for funding services and programs under chapter 271, Laws
- 35 of 1989 and chapter 7, Laws of 1994 sp. sess., including state
- 36 incarceration costs. Funds from the account may also be appropriated
- 37 to reimburse local governments for costs associated with implementing
- 38 criminal justice legislation including chapter 338, Laws of 1997.

- 1 During the 1997-1999 biennium, funds from the account may also be used
- 2 for costs associated with conducting a feasibility study of the
- 3 department of corrections' offender-based tracking system and providing
- 4 grants to local governments in accordance with chapter 338, Laws of
- 5 <u>1997</u>. After July 1, 1999, at least seven and one-half percent of
- 6 expenditures from the account shall be used for providing grants to
- 7 community networks under chapter 70.190 RCW by the family policy
- 8 council.
- 9 <u>NEW SECTION.</u> **Sec. 905.** This act shall not be construed as
- 10 affecting any right or cause of action asserted in Washington State
- 11 Legislature v. State of Washington (Thurston county superior court
- 12 cause no. 98-2-00105-1).
- 13 **Sec. 906.** If any provision of this act or its application to any
- 14 person or circumstance is held invalid, the remainder of the act or the
- 15 application of the provision to other persons or circumstances is not
- 16 affected.
- 17 **Sec. 907.** This act is necessary for the immediate preservation of
- 18 the public peace, health, or safety, or support of the state government
- 19 and its existing public institutions, and takes effect immediately.
