- (3) Moneys from the account shall be distributed as follows: 6 7 For subaccounts of state baccalaureate institutions, (i) seventy-five 8 percent to the distinguished professorship trust fund under RCW 28B.10.868, and (ii) twenty-five percent to the graduate fellowship trust fund under RCW 28B.10.882; and (b) for subaccounts of state 10 community and technical colleges, to the college faculty awards trust 11 fund under RCW 28B.50.837. Amounts distributed to the trust funds from 12 13 the subaccounts shall be disbursed from the trust funds only on behalf of the institution whose subaccount contributed the amounts to the 14 15 trust fund."

EFFECT: State institutions of higher education are not eliqible to 17 participate in the Savings Incentive Account. 18 The Higher Education Savings Account is established. A subaccount within the account is 19 20 created for each institution. To the extent that state institutions of 21 higher education do not fully expend each year's general fund--state appropriations, and to the extent that the legislature reappropriates 22 savings to the higher education savings 23 account, 24 institution's savings will be recaptured and deposited into that institution's subaccount. The treasurer shall distribute the moneys as 25 follows: (1) For the subaccounts of the four-year institutions, 75% 26 27 will be deposited into the distinguished professorship trust fund and 28 25% into the graduate fellowship trust fund; and (2) for the 29 subaccounts of the community and technical colleges, moneys will be 30 deposited into the college faculty awards trust fund. Moneys deposited in the trust funds from the subaccounts may be expended only on behalf 31 32 of the institution whose subaccount contributed to the trust fund.
