- 30 of a crop requiring irrigation in the amounts asserted in the statement
- 31 of claim or of livestock requiring water in such amounts; or records of

- 33 indicating that irrigation in the amount claimed was required to

- 35 (c) Receipts or records of equipment purchases or repairs
- 36 associated with the water use specified in the statement of claim;

- 1 (d) Water well construction records identifying the date the well 2 specified in the statement of claim as the point of withdrawal was 3 constructed;
- 4 (e) Records of electricity bills directly associated with the 5 withdrawal of water as specified in the statement of claim;
- 6 (f) Personal records such as photographs, journals, or 7 correspondence indicating the use of water as asserted in the statement 8 of claim;
- 9 (g) Records of a water district or association indicating 10 construction of a water delivery system or of water use.

A right granted under this section shall not affect or impair in 11 any respect whatsoever a water right existing prior to September 1, 12 1997. A right granted under this section shall be junior in every 13 respect to a right with a more senior date of priority. The filing of 14 15 a statement of claim under this section does not constitute an adjudication of any claim to the right to the use of waters as between 16 the claimant and the state, or as between one or more water use 17 claimants and another or others. A statement of claim filed under this 18 19 section shall be admissible in a general adjudication of water rights as prima facie evidence of the times of use and the quantity of water 20 the claimant was withdrawing or diverting to the same extent as is 21 provided by RCW 90.14.081 for a statement of claim in the water rights 22 claims registry on the effective date of this section. 23

24 This section does not apply to ground water withdrawn in an area 25 that is, during the period established by subsection (2) of this 26 section, the subject of a general adjudication proceeding for water rights in superior court under RCW 90.03.110 through 90.03.245 and the 27 proceeding applies to ground water rights. This section does not apply 28 29 to surface water withdrawn in an area that is, during the period 30 established by subsection (2) of this section, the subject of a general adjudication proceeding for water rights in superior court under RCW 31 90.03.110 through 90.03.245 and the proceeding applies to surface water 32 This section does not apply to rights embodied in a water 33 34 right permit or certificate issued by the department of ecology or its 35 predecessors, a water right represented by a claim in the water rights claims registry, created under RCW 90.14.111, prior to September 1, 36 37 1997, or a water right exempted from permit and application requirements by RCW 90.44.050." 38
