- 28 (a) Who has been abandoned; that is, where the child's parent, quardian, or other custodian has expressed either by statement or 29 30 conduct, an intent to forego, for an extended period, parental rights or parental responsibilities despite an ability to do so. If the court 31 finds that the petitioner has exercised due diligence in attempting to 32 locate the parent, no contact between the child and the child's parent, 33 34 guardian, or other custodian for a period of three months creates a 35 rebuttable presumption of abandonment, even if there is no expressed intent to abandon; 36

- 1 (b) Who is abused or neglected as defined in chapter 26.44 RCW by 2 a person legally responsible for the care of the child;
- 3 (c) Who has no parent, guardian, or custodian capable of adequately 4 caring for the child, such that the child is in circumstances which 5 constitute a danger of substantial damage to the child's psychological 6 or physical development; or

- (d) Who has a developmental disability, as defined in RCW 71A.10.020 and whose parent, guardian, or legal custodian together with the department determines that services appropriate to the child's needs can not be provided in the home. However, (a), (b), and (c) of this subsection may still be applied if other reasons for removal of the child from the home exist.
- (5) "Guardian" means the person or agency that: (a) Has been appointed as the guardian of a child in a legal proceeding other than a proceeding under this chapter; and (b) has the legal right to custody of the child pursuant to such appointment. The term "guardian" shall not include a "dependency guardian" appointed pursuant to a proceeding under this chapter.
- (6) "Guardian ad litem" means a person, appointed by the court to represent the best interest of a child in a proceeding under this chapter, or in any matter which may be consolidated with a proceeding under this chapter. A "court-appointed special advocate" appointed by the court to be the guardian ad litem for the child, or to perform substantially the same duties and functions as a guardian ad litem, shall be deemed to be guardian ad litem for all purposes and uses of this chapter.
- (7) "Guardian ad litem program" means a court-authorized volunteer program, which is or may be established by the superior court of the county in which such proceeding is filed, to manage all aspects of volunteer guardian ad litem representation for children alleged or found to be dependent. Such management shall include but is not limited to: Recruitment, screening, training, supervision, assignment, and discharge of volunteers.
- 34 (8) "Out-of-home care" means placement in a foster family home or 35 group care facility licensed pursuant to chapter 74.15 RCW or placement 36 in a home, other than that of the child's parent, guardian, or legal 37 custodian, not required to be licensed pursuant to chapter 74.15 RCW.

- If, after a fact-finding hearing pursuant to RCW 13.34.110, it has been proven by a preponderance of the evidence that the child is dependent within the meaning of RCW 13.34.030; after consideration of the predisposition report prepared pursuant to RCW 13.34.110 and after a disposition hearing has been held pursuant to RCW 13.34.110, the court shall enter an order of disposition pursuant to this section.
- 11 (1) The court shall order one of the following dispositions of the 12 case:
- (a) Order a disposition other than removal of the child from his or her home, which shall provide a program designed to alleviate the immediate danger to the child, to mitigate or cure any damage the child has already suffered, and to aid the parents so that the child will not be endangered in the future. In selecting a program, the court should choose those services that least interfere with family autonomy, provided that the services are adequate to protect the child.

- (3) Whenever a child is ordered removed from the child's home, the agency charged with his or her care shall provide the court with:
- 8 (a) A permanency plan of care that shall identify one of the 9 following outcomes as a primary goal and may identify additional 10 outcomes as alternative goals: Return of the child to the home of the child's parent, guardian, or legal custodian; adoption; guardianship; 11 permanent legal custody; or long-term relative or foster care, until 12 13 the child is age eighteen, with a written agreement between the parties and the care provider; and independent living, if appropriate and if 14 15 the child is age sixteen or older. Whenever a permanency plan 16 identifies independent living as a goal, the plan shall also specifically identify the services that will be provided to assist the 17 child to make a successful transition from foster care to independent 18 19 Before the court approves independent living as a permanency 20 plan of care, the court shall make a finding that the provision of services to assist the child in making a transition from foster care to 21 independent living will allow the child to manage his or her financial 22 affairs and to manage his or her personal, social, educational, and 23 24 nonfinancial affairs. All aspects of the plan shall include the goal of achieving permanence for the child.
- 33 (i) The agency plan shall specify what services the parents will be 34 offered in order to enable them to resume custody, what requirements 35 the parents must meet in order to resume custody, and a time limit for 36 each service plan and parental requirement.
- (ii) The agency shall be required to encourage the maximum parentsecond contact possible, including regular visitation and participation by the parents in the care of the child while the child is in

1 placement. Visitation may be limited or denied only if the court 2 determines that such limitation or denial is necessary to protect the 3 child's health, safety, or welfare.

It shall report to the court if it is unable to provide such services.
- (c) If the court has ordered, pursuant to subsection (2) of this section, that a termination petition be filed, a specific plan as to where the child will be placed, what steps will be taken to achieve permanency for the child, services to be offered or provided to the child, and, if visitation would be in the best interests of the child, a recommendation to the court regarding visitation between parent and child pending a fact-finding hearing on the termination petition. The agency shall not be required to develop a plan of services for the parents or provide services to the parents.
- (4) If there is insufficient information at the time of the disposition hearing upon which to base a determination regarding the suitability of a proposed placement with a relative, the child shall remain in foster care and the court shall direct the supervising agency to conduct necessary background investigations as provided in chapter 74.15 RCW and report the results of such investigation to the court within thirty days. However, if such relative appears otherwise suitable and competent to provide care and treatment, the criminal history background check need not be completed before placement, but as soon as possible after placement. Any placements with relatives, pursuant to this section, shall be contingent upon cooperation by the relative with the agency case plan and compliance with court orders related to the care and supervision of the child including, but not limited to, court orders regarding parent-child contacts and any other conditions imposed by the court. Noncompliance with the case plan or court order shall be grounds for removal of the child from the relative's home, subject to review by the court.

- (5) Except for children whose cases are reviewed by a citizen 1 review board under chapter 13.70 RCW, the status of all children found 2 3 to be dependent shall be reviewed by the court at least every six 4 months from the beginning date of the placement episode or the date dependency is established, whichever is first, at a hearing in which it 5 shall be determined whether court supervision should continue. 6 7 review shall include findings regarding the agency and parental completion of disposition plan requirements, and if necessary, revised 8 9 permanency time limits.
- 10 (a) A child shall not be returned home at the review hearing unless
 11 the court finds that a reason for removal as set forth in this section
 12 no longer exists. The parents, guardian, or legal custodian shall

- (vii) Whether additional services are needed to facilitate the return of the child to the child's parents; if so, the court shall order that reasonable services be offered specifying such services; and
- (viii) The projected date by which the child will be returned home or other permanent plan of care will be implemented.

- 1 (c) The court at the review hearing may order that a petition 2 seeking termination of the parent and child relationship be filed.
- 3 Sec. 3. RCW 13.34.145 and 1995 c 311 s 20 and 1995 c 53 s 2 are 4 each reenacted and amended to read as follows:
- 5 (1) A permanency plan shall be developed no later than sixty days 6 from the time the supervising agency assumes responsibility for 7 providing services, including placing the child, or at the time of a 8 hearing under RCW 13.34.130, whichever occurs first. The permanency 9 planning process continues until a permanency planning goal is achieved 10 or dependency is dismissed. The planning process shall include 11 reasonable efforts to return the child to the parent's home.

(i) "Guardianship" means a dependency guardianship pursuant to this chapter, a legal guardianship pursuant to chapter 11.88 RCW, or equivalent laws of another state or a federally recognized Indian tribe.
