- 1 (1) "Boat wastes" includes, but is not limited to, sewage, garbage, 2 marine debris, plastics, contaminated bilge water, cleaning solvents, 3 paint scrapings, or discarded petroleum products associated with the 4 use of vessels.
- 5 (2) "Boater" means any person on a vessel on waters of the state of 6 Washington.

- (3) "Carrying passengers for hire" means carrying passengers in a vessel on waters of the state for valuable consideration, whether given directly or indirectly or received by the owner, agent, operator, or other person having an interest in the vessel. This shall not include trips where expenses for food, transportation, or incidentals are shared by participants on an even basis. Anyone receiving compensation for skills or money for amortization of equipment and carrying passengers shall be considered to be carrying passengers for hire on waters of the state.
 - (4) "Commission" means the state parks and recreation commission.
 - (5) "Darkness" means that period between sunset and sunrise.
- 18 (6) "Environmentally sensitive area" means a restricted body of 19 water where discharge of untreated sewage from boats is especially 20 detrimental because of limited flushing, shallow water, commercial or 21 recreational shellfish, swimming areas, diversity of species, the 22 absence of other pollution sources, or other characteristics.
 - (7) "Guide" means any individual, including but not limited to subcontractors and independent contractors, engaged for compensation or other consideration by a whitewater river outfitter for the purpose of operating vessels. A person licensed under RCW 77.32.211 or 75.28.780 and acting as a fishing guide is not considered a guide for the purposes of this chapter.
- 29 (8) "Marina" means a facility providing boat moorage space, fuel, 30 or commercial services. Commercial services include but are not 31 limited to overnight or live-aboard boating accommodations.
- (9) "Motor driven boats and vessels" means all boats and vessels which are self propelled.
- 34 (10) "Muffler" or "muffler system" means a sound suppression device 35 or system, including an underwater exhaust system, designed and 36 installed to abate the sound of exhaust gases emitted from an internal 37 combustion engine and that prevents excessive or unusual noise.
- 38 (11) "Operate" means to steer, direct, or otherwise have physical 39 control of a vessel that is underway.

- 1 (12) "Operator" means an individual who steers, directs, or 2 otherwise has physical control of a vessel that is underway or 3 exercises actual authority to control the person at the helm.
- 4 (13) "Observer" means the individual riding in a vessel who is 5 responsible for observing a water skier at all times.
- 6 (14) "Owner" means a person who has a lawful right to possession of 7 a vessel by purchase, exchange, gift, lease, inheritance, or legal 8 action whether or not the vessel is subject to a security interest.
- 9 (15) "Person" means any individual, sole proprietorship, 10 partnership, corporation, nonprofit corporation or organization, 11 limited liability company, firm, association, or other legal entity 12 located within or outside this state.
- 13 (16) "Personal flotation device" means a buoyancy device, life 14 preserver, buoyant vest, ring buoy, or buoy cushion that is designed to 15 float a person in the water and that is approved by the commission.
- 16 (17) "Personal watercraft" means a vessel of less than sixteen feet 17 that uses a motor powering a water jet pump, as its primary source of 18 motive power and that is designed to be operated by a person sitting, 19 standing, or kneeling on, or being towed behind the vessel, rather than 20 in the conventional manner of sitting or standing inside the vessel.
- 21 (18) "Polluted area" means a body of water used by boaters that is 22 contaminated by boat wastes at unacceptable levels, based on applicable 23 water quality and shellfish standards.
- (19) "Public entities" means all elected or appointed bodies, including tribal governments, responsible for collecting and spending public funds.
- (20) "Reckless" or "recklessly" means acting carelessly and heedlessly in a willful and wanton disregard of the rights, safety, or property of another.
 - (21) "Sewage pumpout or dump unit" means:

- 31 (a) A receiving chamber or tank designed to receive vessel sewage 32 from a "porta-potty" or a portable container; and
- 33 (b) A stationary or portable mechanical device on land, a dock, 34 pier, float, barge, vessel, or other location convenient to boaters, 35 designed to remove sewage waste from holding tanks on vessels.
- 36 (22) "Underway" means that a vessel is not at anchor, or made fast 37 to the shore, or aground.
- 38 (23) "Vessel" includes every description of watercraft on the 39 water, other than a seaplane, used or capable of being used as a means

- of transportation on the water. However, it does not include inner tubes, air mattresses, <u>sailboards</u>, and small rafts or flotation devices or toys customarily used by swimmers.
- 4 (24) "Water skiing" means the physical act of being towed behind a 5 vessel on, but not limited to, any skis, aquaplane, kneeboard, tube, or 6 any other similar device.
- 7 (25) "Waters of the state" means any waters within the territorial 8 limits of Washington state.
- 9 (26) "Whitewater river outfitter" means any person who is 10 advertising to carry or carries passengers for hire on any whitewater 11 river of the state, but does not include any person whose only service 12 on a given trip is providing instruction in canoeing or kayaking 13 skills.
- 14 (27) "Whitewater rivers of the state" means those rivers and 15 streams, or parts thereof, within the boundaries of the state as listed 16 in RCW 88.12.265 or as designated by the commission under RCW 17 88.12.279."
