10 ((+1)) (a) To display or cause or permit to be displayed or have
11 in his or her possession any fictitious or fraudulently altered
12 driver's license or identicard;

13 ((+2)) (b) To lend his or her driver's license or identicard to
14 any other person or knowingly permit the use thereof by another;

15 ((+3)) (c) To display or represent as one's own any driver's
16 license or identicard not issued to him or her;

17 ((+4)) (d) Willfully to fail or refuse to surrender to the
18 department upon its lawful demand any driver's license or identicard
19 which has been suspended, revoked or canceled;

20 ~~((+5) To use a false or fictitious name in any application for a
21 driver's license or identicard or to knowingly make a false statement
22 or to knowingly conceal a material fact or otherwise commit a fraud in
23 any such application;~~

24 (+6)) (e) To permit any unlawful use of a driver's license or
25 identicard issued to him or her.

26 (2) It is a class C felony:

27 (a) To use a false or fictitious name in any application for a
28 driver's license or identicard or to knowingly make a false statement
29 or to knowingly conceal a material fact or otherwise commit a fraud in
30 any such application;

31 (b) To counterfeit or fraudulently alter a driver's license or
32 identicard.

33 **Sec. 13.** RCW 46.20.091 and 1996 c 287 s 5 are each amended to read
34 as follows:

1 (1) Every application for an instruction permit or for an original
2 driver's license shall be made upon a form prescribed and furnished by
3 the department which shall be sworn to and signed by the applicant
4 before a person authorized to administer oaths. (~~An applicant making~~
5 ~~a false statement under this subsection is guilty of false swearing, a~~
6 ~~gross misdemeanor, under RCW 9A.72.040.~~) Every application for an
7 instruction permit containing a photograph shall be accompanied by a
8 fee of five dollars. The department shall forthwith transmit the fees
9 collected for instruction permits and temporary drivers' permits to the
10 state treasurer.

11 (2) Every such application shall state the full name, date of
12 birth, sex, and Washington residence address of the applicant, and
13 briefly describe the applicant, and shall state whether the applicant
14 has theretofore been licensed as a driver or chauffeur, and, if so,
15 when and by what state or country, and whether any such license has
16 ever been suspended or revoked, or whether an application has ever been
17 refused, and, if so, the date of and reason for such suspension,
18 revocation, or refusal, and shall state such additional information as
19 the department shall require, including a statement that identifying
20 documentation presented by the applicant is valid. Except for
21 submitting a digital photograph as authorized by section 3 of this act,
22 the department shall neither request nor require an applicant to submit
23 biometrics as part of an application under this section.

24 (3) Whenever application is received from a person previously
25 licensed in another jurisdiction, the department shall request a copy
26 of such driver's record from such other jurisdiction. When received,
27 the driving record shall become a part of the driver's record in this
28 state.

29 (4) Whenever the department receives request for a driving record
30 from another licensing jurisdiction, the record shall be forwarded
31 without charge if the other licensing jurisdiction extends the same
32 privilege to the state of Washington. Otherwise there shall be a
33 reasonable charge for transmittal of the record, the amount to be fixed
34 by the director of the department.
