BACKGROUND:

Municipal of the ficers reprohibited the municipal ode of ethics from having a beneficial terestina contract with restly indirect which is made by, throughounder the supervision of that officer municipal officers any elected or appointed of include any deputie and assistants that officer.

A number of exemptions to this prohibition we been established or certain municipalition include on tracts or unskilled both at do not exceed \$100 in a calendam on th; contracts nwhich the total volume of business represented the contract in which the municipal fficer besiness interested besonot exceed \$750 in any calendam on th; and contracts y a second class it prown, noncharter code city or county fairboard in a county which does not have a purchasing department in which the total olume of business exceeds this 750 monthly limit the total mount of such contracts on texceed \$9,000 in any calendar ear.

The dollathresholdsstablishedrthesecontracts avenotheen changed formany years and the thresholds pplytothetotal alue of the contract instead of the portion of the contract hat would be nefithemunicipal of ficers in ess The exemptions are also very difficultive adand understand.

A municipadifficeirs not allowed to vote on the authorization is contractiff the officeirs the supplied contractor here is no prohibitiangains municipadifficers voting on other contracts which they may be beneficially the rested.
