SUMMARY:

The stateprogram for minority nd women owned businesses is altered nd expanded to be a program for businesses when and controlled minorities, women, and disable persons. Several provisions flaw relating minority nd women owned businesses reamended to include usinesses when and controlled by disable persons. However, the renamed Office of Minority Women's, and Disable persons is not authorized adopt goals for the participat in the participation of businesses when and controlled disable persons.

A disable personis defined as a person with a physical mental impairment hat substantial impair major lifectivity. The impairment must be material and medically ognizable rdiagnosable and must be permanent but does not include drugoral cohold diction rany negative ffects roughton by the use of drugsor alcohol.

The Legislatufends that no court has held that a program to promote contracting opportunities rbusinesses when and controlled disable persons must be subject to the strict-scrustand arder must be justifiled a disparist udy.—

If a court of proper jurisdict fixed statt he program for disable persons is subject to such a standard rmust be justifiled such a study, the program is suspended until the legislature termines proper course of action.
