BACKGROUND:

Proceduresoelect persontofialwacancyinnon-partisemectedfficenthenthan a judicianticon the Office of Superintendent Public Instruction, llow the same procedure for electing personto a full term of such an office.

However, procedure soelecta persontofilal vacancy in a partisamle ctedifice, judicia fifice, nd the Office f Superintende noti Public Instruction mewhat vary from the procedure for electingers on stoful terms of such offices.

1. Localnon-partisamfficestherthanjudiciaffices.

A primary sheld to nominate persons as part of the process of electing person to a fuller minal ocahon-part is an fice therethan a judicial fice only if three or more persons are candidate for such an office.

If a vacancy occurs in such a location-partise office, person is elected of ithe remaining ermatthem extreme at lection an odd-number of earoccurring or more days after the vacancy occurred. A primary is held as part of this special election occurs of the ermore persons are candidates of ither emaining erm for the vacant of fice and time exists ohold a primary.

Partisaelecteoffices.

If a vacancy occurs in the office fa superior our tjudge a person is elected of ill the remaining erm at the next generablection a primary is held as part of the process to file vacancy in such an office only if time exists and three or more persons file clarations candidact of ithe vacancy.

SUMMARY:

Procedures of ill vacancy in all elected of fice sollow the normal procedure by which a personise lected oa fullerm of that of fice i, ncluding he holding of a primary; fit impermits.
