- AN ACT Relating to tuition waivers; amending RCW 28B.15.558; and
- 2 repealing RCW 28B.15.535.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 28B.15.558 and 1996 c 305 s 3 are each amended to read 5 as follows:
- 6 (1) The governing boards of the state universities, the regional 7 universities, The Evergreen State College, and the community colleges
- 8 may waive all or a portion of the tuition and services and activities
- 9 fees for state employees as defined under subsection (2) of this
- 10 section and members of the Washington national guard. The enrollment
- 11 of these persons is pursuant to the following conditions:
- 12 (a) Such ((state employees)) persons shall register for and be 13 enrolled in courses on a space available basis and no new course
- 14 sections shall be created as a result of the registration;
- 15 (b) Enrollment information on ((state employees)) persons
- 16 registered pursuant to this section shall be maintained separately from
- 17 other enrollment information and shall not be included in official
- 18 enrollment reports, nor shall such ((state employees)) persons be

- 1 considered in any enrollment statistics ((which)) that would affect 2 budgetary determinations; and
- 3 (c) ((State employees)) Persons registering on a space available 4 basis shall be charged a registration fee of not less than five 5 dollars.
- 6 (2) For the purposes of this section, "state employees" means
  7 persons employed half-time or more in one or more of the following
  8 employee classifications:
- 9 <u>(a) Permanent employees ((employed half-time or more))</u> in 10 classified service under chapter 41.06 RCW;
- 11 <u>(b) Permanent employees ((employed half-time or more who are))</u>
  12 governed by chapter 41.56 RCW pursuant to the exercise of the option
  13 under RCW 41.56.201;
- 14 <u>(c) Permanent classified employees and exempt paraprofessional</u>
  15 employees of technical colleges ((employed half-time or more)); and
  16 ((nonacademic))
- (d) Faculty, counselors, librarians, and exempt professional and administrative employees ((and members of the faculties and instructional staff employed half-time or more)) at institutions of higher education as defined in RCW 28B.10.016.
- 21 (3) In awarding waivers, an institution of higher education may 22 award waivers to eligible persons employed by the institution before 23 considering waivers for eligible persons who are not employed by the 24 institution.
- 25 (4) If an institution of higher education exercises the authority 26 granted under this section, it shall include all eligible state 27 employees and members of the Washington national guard in the pool of 28 persons eligible to participate in the program.
- 29 <u>(5) In establishing eligibility to receive waivers, institutions of</u> 30 <u>higher education may not discriminate between full-time employees and</u> 31 <u>employees who are employed half-time or more.</u>
- NEW SECTION. Sec. 2. RCW 28B.15.535 and 1996 c 6 s 1, 1992 c 231 s 15, 1985 c 390 s 28, 1983 c 220 s 1, & 1979 c 82 s 2 are each repealed.
