SUBSTITUTE HOUSE BILL 1319

- 1 AN ACT Relating to increasing anadromous fish runs in the Elwha
- 2 river; adding a new section to chapter 75.50 RCW; creating new
- 3 sections; and making an appropriation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that the Elwha river's
- 6 remaining fish stocks have reached dangerously low levels. Pending the
- 7 outcome of dam removal proposals, the river's remaining native
- 8 anadromous fish stocks must be preserved and increased.
- 9 It is the intent of the legislature that the native anadromous fish
- 10 runs of the Elwha river be increased and protected from possible
- 11 extinction and that future choices for fisheries restoration not be
- 12 foreclosed.
- 13 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 75.50 RCW
- 14 to read as follows:
- 15 The department shall continue to cooperate with the Lower Elwha
- 16 Klallam Tribe and the federal resource agencies in refining and
- 17 implementing short-term action plans which preserve and increase
- 18 existing native stocks in the Elwha river. In addition, the department

- 1 shall work with the federal resource agencies and the Lower Elwha
- 2 Klallam Tribe to develop and implement short and long-term restoration
- 3 actions to reintroduce native salmon into the tributaries and mainstem
- 4 Elwha river above river mile 4.9.
- 5 <u>NEW SECTION.</u> **Sec. 3.** To prepare for the possibility that the
- 6 Elwha dam is not removed, the department of fish and wildlife shall
- 7 prepare a contingency plan to reintroduce native salmon into the
- 8 tributaries above river mile 4.9 by June 30, 1998. Upon completion,
- 9 the plan shall be submitted to the appropriate standing committees of
- 10 the legislature. The plan shall include a detailed list of actions and
- 11 timelines necessary to reintroduce native salmon above river mile 4.9.
- 12 <u>NEW SECTION.</u> **Sec. 4.** The sum of two hundred ninety-five thousand
- 13 dollars, or as much thereof as may be necessary, is appropriated for
- 14 the biennium ending June 30, 1999, from the general fund to the
- 15 department of fish and wildlife for the purpose of enhancing anadromous
- 16 salmon stocks in the Elwha river as follows:
- 17 (1) Twenty-five thousand dollars is provided for additional cool
- 18 water habitat for chinook below the Elwha dam;
- 19 (2) Twenty thousand dollars is provided solely to identify the
- 20 return timing of rainbow trout returning to the upper river;
- 21 (3) One hundred fifty thousand dollars is provided to reduce the
- 22 mortality of prespawning chinook in the lower river; and
- 23 (4) One hundred thousand dollars is provided to develop a
- 24 contingency plan for reintroduction of native salmon into the
- 25 tributaries above the Elwha dam.
