- 1 AN ACT Relating to making appropriations to assist retired dentists
- 2 to provide dental services to children in rural and underserved
- 3 communities; creating a new section; and making appropriations.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature recognizes that establishing
- 6 good oral health care habits in a child is important in maintaining the
- 7 overall health of the child. The legislature also recognizes that
- 8 economically disadvantaged parents face challenges that can be daunting
- 9 in securing adequate dental care services for their children in rural
- 10 and underserved communities. As these communities struggle to meet the
- 11 dental care needs of economically disadvantaged families, the
- 12 legislature finds there exists a valuable resource for the provision of
- 13 dental care services through retired dentists. However, many retired
- 14 dentists who are willing to devote their skills and energies to
- 15 improving and maintaining the dental health of economically
- 16 disadvantaged children also face economic barriers to performing their
- 17 valuable services.
- 18 It is the intent of the legislature to improve access to dental
- 19 care services to economically disadvantaged children and families by

- 1 providing resources to overcome many of the barriers that inhibit
- 2 retired dentists from devoting their services to the improvement of
- 3 children's dental health.
- 4 <u>NEW SECTION.</u> **Sec. 2.** The sum of one hundred thousand dollars from
- 5 the general fund--state is appropriated for fiscal year 1998 to the
- 6 department of health solely for the purpose of the volunteer retired
- 7 provider program. Funds must be used solely to increase participation
- 8 by retired dentists and for the payment of malpractice insurance and
- 9 professional licensing fees for retired dentists participating in the
- 10 program.
- 11 <u>NEW SECTION.</u> **Sec. 3.** The sum of one hundred thousand dollars from
- 12 the general fund--state is appropriated for fiscal year 1999 to the
- 13 department of health solely for the purpose of the volunteer retired
- 14 provider program. Funds must be used solely to increase participation
- 15 by retired dentists and for the payment of malpractice insurance and
- 16 professional licensing fees for retired dentists participating in the
- 17 program.
