- 1 AN ACT Relating to a model ordinance for cities, towns, and
- 2 counties for the regulation of live adult entertainment establishments;
- 3 adding a new chapter to Title 18 RCW; and prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** This act may be known and cited as the live
- 6 adult entertainment establishment model licensing act.
- 7 NEW SECTION. Sec. 2. The purpose of this chapter is to encourage
- 8 regulation of the negative secondary impacts of live adult
- 9 entertainment on the health, safety, and welfare of the citizens of
- 10 this state by providing a comprehensive compilation of sound, uniform
- 11 laws for licensing and regulating conduct in live adult entertainment
- 12 establishments. These uniform laws are provided to serve as a model
- 13 that local jurisdictions may adopt by reference in whole or in part,
- 14 including all future amendments or additions to the laws. A local
- 15 jurisdiction that adopts this chapter by reference may at any time
- 16 exclude any section or sections from this chapter that the local
- 17 jurisdiction does not desire to include in its local ordinance. This
- 18 chapter is not intended to deny a local jurisdiction its legislative

- l power, but rather to enhance regulation of the negative secondary
- 2 impacts of live adult entertainment throughout the state by having
- 3 uniform laws available. This chapter may not be construed as
- 4 permitting or promoting lewd or obscene conduct.

## 5 NEW SECTION. Sec. 3. The legislature finds that:

- (1) Live adult entertainment establishments require special supervision from the public safety agencies of the cities, towns, and counties in which the establishments might locate in order to protect and preserve the health, safety, and welfare of the patrons of the
- 10 establishments as well as the citizens of the state;
- 11 (2) Live adult entertainment establishments are frequently used for 12 unlawful activities, including prostitution and sexual exploitation of 13 minors and the illegal use and sale of narcotics;
- 14 (3) The concern over sexually transmitted diseases is a legitimate 15 health concern of the state that demands reasonable regulation of live 16 adult entertainment establishments in order to protect the health and 17 well-being of the citizens;
- (4) Local licensing is a legitimate and reasonable means of accountability to ensure that operators of live adult entertainment establishments comply with reasonable regulations and to ensure that operators do not knowingly allow their establishments to be used as places of illegal sexual activity or solicitation;
- (5) Live adult entertainment establishments, due to their nature, have secondary adverse impacts upon the health, safety, and welfare of the citizenry through increases in crime and increases in the opportunity for the spread of sexually transmitted diseases;
  - (6) It is not the intent of this legislation to suppress speech activities protected by the First Amendment to the United States Constitution or Article I, section 5 of the state Constitution, but to enact content neutral legislation that addresses the negative secondary impacts of live adult entertainment establishments; and
- (7) The financial resources of many cities, towns, and counties in this state are limited, making it difficult for those jurisdictions to conduct studies necessary to enact local legislation and to address legal challenges to the local legislation. The model ordinance adopted in this chapter will provide a means by which local jurisdictions can adopt reasonable time, place, and manner regulations of live adult

- 3 <u>NEW SECTION.</u> **Sec. 4.** The addition of a new section to, or
- 4 amendment or repeal of a section in, this chapter by the legislature is
- 5 deemed to amend an ordinance of a city, town, or county that has
- 6 adopted by reference this chapter or any part of this chapter, and it
- 7 is not necessary for the legislative authority of a city, town, or
- 8 county to take an action with respect to the addition, amendment, or
- 9 repeal notwithstanding RCW 35.21.180, 35A.12.140, 35A.13.180, and
- 10 36.32.120(7).
- 11 <u>NEW SECTION.</u> **Sec. 5.** The definitions in this section apply
- 12 throughout this chapter unless the context clearly requires otherwise.
- 13 (1) "Adult entertainment" means:
- 14 (a) An exhibition, performance, or dance conducted in a premises
- 15 where the exhibition, performance, or dance involves a person who is
- 16 nude or seminude. "Adult entertainment" includes, but is not limited
- 17 to, a performance commonly known as "striptease";
- 18 (b) An exhibition, performance, or dance conducted in a premises
- 19 where the exhibition, performance, or dance is distinguished or
- 20 characterized by a predominant emphasis on the depiction, description,
- 21 simulation, or relation to the following specified sexual activities:
- (i) Human genitals in a state of sexual stimulation or arousal;
- 23 (ii) Acts of human masturbation, sexual intercourse, sodomy, oral
- 24 copulation, or bestiality; or
- 25 (iii) Fondling or other erotic touching of human genitals, pubic
- 26 region, buttocks, or female breasts; or
- 27 (c) An exhibition, performance, or dance that is intended to
- 28 sexually stimulate a member of the public. This includes, but is not
- 29 limited to, such an exhibition, performance, or dance performed for,
- 30 arranged with, or engaged in with fewer than all members of the public
- 31 on the premises at that time, with separate consideration paid, either
- 32 directly or indirectly, for the performance, exhibition, or dance and
- 33 that is commonly referred to as table dancing, couch dancing, taxi
- 34 dancing, lap dancing, private dancing, or straddle dancing.
- 35 (2) "Applicant" means the individual or entity seeking a live adult
- 36 entertainment establishment license.

- 1 (3) "Applicant control person" means all partners, corporate 2 officers and directors, and other individuals in the applicant's 3 business organization who hold a significant interest in the live adult 4 entertainment business, based on responsibility for management of the 5 live adult entertainment establishment.
- 6 (4) "Clerk" means an employee or agent of the jurisdiction 7 designated to administer this chapter or a designee of the employee or 8 agent.
- 9 (5) "Employee" means a person, including a manager, entertainer, or 10 an independent contractor, who works in or at, or renders services 11 directly related to the operation of, a live adult entertainment 12 establishment.
- 13 (6) "Entertainer" means a person who provides adult entertainment 14 within a live adult entertainment establishment, whether or not a fee 15 is charged or accepted for the entertainment.
  - (7) "Liquor" means a beverage defined in RCW 66.04.010.
- 17 (8) "Live adult entertainment establishment" means a commercial 18 premises to which a member of the public is invited or admitted and 19 where an entertainer provides live adult entertainment to a member of 20 the public on a regular basis or as a substantial part of the premises 21 activity.
- (9) "Manager" means a person who manages, directs, administers, or is in charge of the affairs or conduct, or the affairs and conduct, of a portion of an activity involving adult entertainment occurring at a live adult entertainment establishment, and includes an assistant manager working with or under the direction of a manager to carry out such affairs or conduct.
- (10) "Member of the public" means a customer, patron, club member, or person, other than an employee, who is invited or admitted to a live adult entertainment establishment.
- 31 (11) "Nude or seminude" means a state of complete or partial 32 undress in such costume, attire, or clothing so as to expose any 33 portion of the female breast below the top of the areola or any portion 34 of the pubic region, anus, buttocks, vulva, or genitals, or human male 35 genitals in a discernibly turgid state, even if completely and opaquely 36 covered.
- 37 (12) "Operator" means a person operating, conducting, or 38 maintaining a live adult entertainment establishment.

- 1 (13) "Person" means an individual, partnership, corporation, trust,
- 2 incorporated or unincorporated association, marital community, joint
- 3 venture, governmental entity, or other entity or group of persons
- 4 however organized.
- 5 (14) "Sexual conduct" means an act of:
- 6 (a) Sexual intercourse within its ordinary meaning, occurring upon 7 a penetration, however slight; or
- 8 (b) A penetration of the vagina or anus, however slight, by an 9 object; or
- 10 (c) A contact between persons involving the sex organs of one 11 person and the mouth or anus of another; or
- 12 (d) Masturbation, manual or instrumental, of oneself or of one 13 person by another; or
- 14 (e) Touching of the sex organs, anus, or female breasts, whether 15 clothed or unclothed, of oneself or of one person by another.
- NEW SECTION. Sec. 6. (1) A person may not conduct, manage, or operate a live adult entertainment establishment unless the person is the holder of a valid and subsisting license from the jurisdiction to do so.
- (2) An entertainer, employee, or manager may not knowingly work in or about, or knowingly perform a service or entertainment directly related to the operation of, an unlicensed live adult entertainment establishment.
- 24 (3) An entertainer may not perform in a live adult entertainment 25 establishment unless the person is the holder of a valid and subsisting 26 license from the jurisdiction to do so.
- 27 (4) A manager may not work in a live adult entertainment 28 establishment unless the person is the holder of a valid and subsisting 29 license from the jurisdiction to do so.
- 30 <u>NEW SECTION.</u> **Sec. 7.** A jurisdiction may not issue a license to:
- 31 (1) A natural person who has not attained the age of twenty-one
- 32 years, except that a license may be issued to a person who has attained
- 33 the age of eighteen years with respect to live adult entertainment
- 34 establishments where no intoxicating liquors are served or provided;
- 35 (2) A person whose place of business is conducted by a manager or 36 agent, unless the manager or agent has obtained a manager's license;

- 1 (3) A partnership, unless all the members of the partnership are 2 qualified to obtain a license. The license must be issued to the 3 manager or agent of the partnership; and
- 4 (4) A corporation, unless all the officers and directors of the 5 corporation are qualified to obtain a license under this chapter. The 6 license must be issued to the manager or agent of the corporation.
- (1) An application for a live adult 7 NEW SECTION. Sec. 8. entertainment establishment license must be submitted to the clerk in 8 9 the name of the person or entity proposing to operate a live adult entertainment establishment on the business premises and must be signed 10 by the person and certified as true under penalty of perjury. 11 12 application must be submitted on a form supplied by the jurisdiction, which must require the following information: 13
- (a) For the applicant and for each applicant control person, provide: Names; aliases or previous names, if any; driver's license number, if any; social security number, if any; business, mailing, and residential address; and business telephone number;
- (b) If a partnership, whether the partnership is general or limited, and if a corporation, the date and place of incorporation; evidence that the partnership or corporation is in good standing under the laws of this state; and the name and address of the registered agent for service of process;
- (c) Whether the applicant or a partner, corporate officer, or director of the applicant holds another license under this chapter or a license for a similar live adult entertainment or sexually oriented business, including a motion picture theater and a panorama, from the jurisdiction or another city or county or state, and, if so, the name and address of each other licensed business;
- (d) A summary of the business history of the applicant and applicant control persons in owning or operating the live adult entertainment or other sexually oriented business, providing names, addresses, and dates of operation for the businesses and whether a business license or live adult entertainment establishment license has been revoked or suspended and the reason for the revocation or suspension;
- (e) For the applicant and all applicant control persons, all criminal convictions or forfeitures within five years immediately preceding the date of the application, other than parking offenses or

- 1 minor traffic infractions, including the dates of conviction, nature of 2 the crime, name and location of the court, and disposition;
- 3 (f) For the applicant and all applicant control persons, a 4 description of business, occupation, or employment history for the 5 three years immediately preceding the date of the application;
- 6 (g) Authorization for the jurisdiction and the jurisdiction's 7 agents and employees to seek information to confirm statements set 8 forth in the application;
- 9 (h) The location and doing-business-as name of the proposed live 10 adult entertainment establishment, including a legal description of the 11 property, street address, and telephone number, together with the name 12 and address of each owner and lessee of the property;
- (i) Two two-inch by two-inch color photographs of the applicant and applicant control persons, taken within six months of the date of application showing only the full face;
- (j) A complete set of fingerprints for the applicant or each applicant control person, taken by the law enforcement agency for the jurisdiction, or such other entity as authorized by the law enforcement agency; and
- (k) A scale drawing or diagram showing the configuration of the 20 premises for the proposed live adult entertainment establishment, 21 including a statement of the total floor space occupied by the 22 business, and marked dimensions of the interior of the premises. 23 24 Performance areas, seating areas, manager's office and stations, 25 restrooms, and service areas must be clearly marked on the drawing. An 26 application for a license for a live adult entertainment establishment 27 must include building plans that demonstrate conformance with the jurisdiction's building code requirements. 28
  - (2) An application must be deemed complete upon the applicant's provision of all information requested in subsection (1) of this section, including the identification of "none" where that is the correct response, and the applicant's verification that the application is complete. The clerk may request other information or clarification in addition to that provided in a complete application if necessary to determine compliance with this chapter.

1 (4) An applicant shall verify, under penalty of perjury, that the 2 information contained in the application is true.

- (5) If, subsequent to the issuance of a live adult entertainment establishment license for a business, a person or entity acquires a significant interest based on responsibility for management or operation of the business, notice of the acquisition must be provided by the business or person or entity in writing to the clerk, no later than twenty-one days following the acquisition. The notice must include the information required for the original live adult entertainment establishment license application.
- 11 (6) The live adult entertainment establishment license, if granted,
  12 must state on its face the name of the person or persons to whom it is
  13 issued, the expiration date, the doing-business-as name, and the
  14 address of the licensed live adult entertainment establishment. The
  15 license must be posted in a conspicuous place at or near the entrance
  16 to the live adult entertainment establishment so that the notice can be
  17 easily read when the business is open.
- 18 (7) A person granted a live adult entertainment establishment 19 license under this chapter may not operate the live adult entertainment 20 establishment under a name not specified on the license, nor may a 21 person operate a live adult entertainment establishment under a 22 designation or at a location not specified on the license.
- (8) Upon receipt of the complete application and fee, the clerk 23 24 shall provide copies to the police, fire, and building departments of 25 the jurisdiction for their investigations and reviews to determine 26 compliance of the proposed live adult entertainment establishment with 27 the laws and regulations that each department administers. department shall, within thirty days of the date of the application, 28 29 inspect the application and premises and shall make a written report to 30 the clerk whether the application and premises comply with the laws 31 administered by the department. A license may not be issued unless each department reports that the applicant and premises comply with the 32 33 relevant laws. If the premises is not yet constructed, the departments 34 shall base their recommendations as to premises compliance on their 35 review of the drawings submitted in the application. A live adult entertainment establishment license approved before the premises 36 37 construction must contain a condition that the premises may not open for business until the premises have been inspected and determined to 38 39 be in substantial conformance with the drawings submitted with the

application. A department shall recommend denial of a license under this subsection if it finds that the proposed live adult entertainment sestablishment is not in conformance with this chapter or other applicable law in effect in the jurisdiction. The department shall cite in a recommendation for denial the specific reason for the denial including applicable laws.

7 (9) The clerk shall issue a live adult entertainment establishment 8 license within thirty days of the date of filing a complete license 9 application and fee unless the clerk determines that the applicant 10 failed to meet a requirement of this chapter, failed to provide information required under this section, or made a false, misleading, 11 or fraudulent statement of material fact on the license application. 12 The clerk shall grant an extension of time in which to provide all 13 14 information required for a complete license application upon the 15 request of the applicant. If the clerk finds that the applicant has 16 failed to meet a requirement for issuance of a live adult entertainment 17 establishment license, the clerk shall deny the application in writing 18 and shall cite the specific reasons for the denial, including 19 applicable laws. If the clerk fails to issue or deny the license within thirty days of the date of filing of a complete application and 20 fee, the applicant may, subject to all other applicable laws, operate 21 22 the business for which the license was sought until notification by the clerk that the license has been denied, but the clerk may not extend 23 24 the applicant review time for more than an additional twenty days.

25 NEW SECTION. Sec. 9. (1) A person may not work as a manager, assistant manager, or entertainer at a live adult entertainment 26 27 establishment without a manager's or an entertainer's license from the jurisdiction. An applicant for a manager's or entertainer's license 28 29 must complete an application on forms provided by the jurisdiction 30 containing the information identified in this subsection. nonrefundable application fee must accompany the application. 31 clerk shall provide a copy of the application to the law enforcement 32 33 agency of the jurisdiction for its review, investigation, 34 recommendation. An application for a manager's or entertainer's license must be signed by the applicant and certified to be true under 35 36 penalty of perjury. The manager's or entertainer's license application 37 must require the following information:

- (a) The applicant's name, home address, home telephone number, date 1 2 and place of birth, fingerprints taken by the law enforcement agency of the jurisdiction or such other entity as authorized by the local law 3 4 enforcement agency, social security number, and any stage names or 5 nicknames used in entertaining;
- The name and address of each live adult entertainment 6 7 establishment at which the applicant intends to work;
- 8 (c) Documentation that the applicant has attained the age of 9 eighteen years. Any two of the following are acceptable 10 documentation of age:
- (i) A motor vehicle operator's license issued by a state, bearing 11 the applicant's photograph and date of birth; 12
- 13 (ii) A state-issued identification card bearing the applicant's photograph and date of birth; 14
- 15 (iii) A passport issued by the United States of America;
- (iv) An immigration card issued by the United States of America; or 16
- (v) Other identification that the jurisdiction determines to be 17 acceptable and reliable; 18
- 19 (d) A complete statement of all convictions of the applicant for misdemeanor or felony violations in the jurisdiction or another city, 20 county, or state within five years immediately preceding the date of 21 22 the application, except parking violations or minor traffic 23 infractions;
- 24 (e) A description of the applicant's principal activities or 25 services to be rendered;
- 26 (f) Two two-inch by two-inch color photographs of the applicant, 27 taken within six months of the date of application showing only the full face; and 28
- 29 (g) Authorization for the city and its agents and employees to 30 investigate and confirm statements in the application.
- 31 (2) The clerk may request additional information or clarification if necessary to determine compliance with this chapter. 32
- (3) An entertainer shall provide the entertainer's license to the 33 34 live adult entertainment establishment manager on duty on the premises 35 before the entertainer's performance. The manager shall retain the license of the entertainer so as to be readily available for inspection 36 by the jurisdiction during business hours of the live adult
- 37

entertainment establishment. 38

- (4) The clerk shall issue a live adult entertainment establishment 1 manager's or entertainer's license within fourteen days from the date 2 3 the complete application and fee are received unless the clerk 4 determines that the applicant failed to provide information required to be supplied according to this chapter, made a false, misleading, or 5 fraudulent statement of material fact in the application, or failed to 6 7 meet a requirement for issuance of a license under this chapter. 8 the clerk determines that the applicant does not qualify for the 9 license, the clerk shall deny the application in writing and shall cite the specific reasons for the denial, including applicable laws. If the 10 clerk fails to approve or deny an application for a live adult 11 entertainment establishment manager's license within fourteen days of 12 13 filing of a complete application, the applicant may, subject to all other applicable laws, commence work as a live adult entertainment 14 15 establishment manager in а licensed live adult entertainment establishment until notified by the clerk that the license is denied, 16 17 but the clerk may not extend the application review time for more than an additional twenty days. 18
- 19 (5) An applicant for an entertainer's license must be issued a 20 temporary license upon receipt of a complete license application and fee. The temporary license automatically expires on the fourteenth day 21 22 following the filing of the complete license application and fee unless 23 the clerk fails to approve or deny the license application, in which 24 case the temporary license is valid until the clerk approves or denies 25 the application or until the final determination of an appeal from a 26 denial of the application. The clerk may not extend the application review time for more than an additional twenty days. 27
- <u>NEW SECTION.</u> **Sec. 10.** The jurisdiction shall fix license fees for 28 29 adult entertainment establishment licenses, live adult 30 entertainment establishment manager's licenses, and live adult entertainer's licenses. The jurisdiction shall base the license fees 31 on the costs to the jurisdiction to process and investigate license 32 applications and to enforce the licensing provisions of this chapter. 33
- NEW SECTION. **Sec. 11.** (1) An applicant may appeal the action of the clerk in refusing to issue or renew a license issued under this chapter. The applicant must file a notice of appeal with the clerk within ten days of issuance of the notice of refusal to issue or renew.

- 1 A hearing body designated by the jurisdiction to hear licensing appeals
- 2 shall hear the appeal. The hearing must be conducted within thirty
- 3 days of the filing of the notice of appeal. At the hearing, the
- 4 appellant and other interested persons may appear and be heard, subject
- 5 to the rules of the hearing body. The hearing body shall render its
- 6 decision in writing within fifteen days of the close of the appeal
- 7 hearing.
- 8 (2) An applicant may appeal a decision of the hearing body rendered
- 9 under subsection (1) of this section by filing a petition for a writ of
- 10 certiorari, prohibition, or mandamus in the superior court within ten
- 11 days of the date the decision of the hearing body is mailed to the

- 13 <u>NEW SECTION.</u> **Sec. 12.** (1) An employee of a live adult
- 14 entertainment establishment shall adhere to the following standards of
- 15 conduct while in an area in which a member of the public is allowed to
- 16 be present:
- 17 (a) An employee may not be unclothed or in such less than opaque
- 18 and complete attire, costume, or clothing so as to expose to view a
- 19 portion of the female breast below the top of the areola or a portion
- 20 of the pubic region, anus, buttocks, vulva, or genitals, except upon a
- 21 stage at least eighteen inches above the immediate floor level and
- 22 removed at least eight feet from the nearest member of the public;
- 23 (b) An employee mingling with a member of the public may not be
- 24 unclothed or in less than opaque and complete attire, costume, or
- 25 clothing as described in (a) of this subsection, nor may a male
- 26 employee appear with his genitals in a discernibly turgid state, even
- 27 if completely and opaquely covered, or wearing or using a device or
- 27 II completely and opaquely covered, or wearing or using a device or
- 28 covering that simulates the same;
- 29 (c) An employee mingling with a member of the public may not wear
- 30 or use a device or covering exposed to view that simulates the breast
- 31 below the top of the areola, vulva, genitals, anus, a portion of the
- 32 pubic region, or buttocks;
- 33 (d) An employee may not caress, fondle, or erotically touch a
- 34 member of the public or another employee. An employee may not
- 35 encourage or permit a member of the public to caress, fondle, or
- 36 erotically touch an employee;
- 37 (e) An employee may not perform an actual or simulated act of
- 38 sexual conduct or an act that constitutes a violation of chapter 7.48A

RCW, the Washington moral nuisance statute, or any local ordinance regulating offenses against public morals;

- (f) An employee mingling with a member of the public may not conduct a dance, performance, or exhibition in or about the nonstage area of the live adult entertainment establishment unless that dance, performance, or exhibition is performed at a distance of at least four feet from the member of the public for whom the dance, performance, or exhibition is performed. The distance of four feet is measured from the torso of the dancer to the torso of the member of the public;
- 10 (g) A tip or gratuity offered to or accepted by an entertainer may not be offered or accepted before a performance, dance, or exhibition 11 provided by the entertainer. An entertainer performing upon a stage 12 13 area may not accept any form of gratuity offered directly to the entertainer by a member of the public. A gratuity offered to an 14 15 entertainer performing upon a stage area must be placed into a receptacle provided for receipt of gratuities by the management of the 16 17 live adult entertainment establishment or provided through a manager on duty on the premises. A gratuity or tip offered to an entertainer 18 19 conducting a performance, dance, or exhibition in or about the nonstage 20 area of the live adult entertainment establishment must be placed into the hand of the entertainer or into a receptacle provided by the 21 entertainer, and not upon the person or into the clothing of the 22 23 entertainer.
- 24 (2) At a live adult entertainment establishment the following are 25 required:
  - (a) Admission must be restricted to persons of the age of eighteen years or older. An owner, operator, manager, or other person in charge of a live adult entertainment establishment may not knowingly permit or allow a person under the age of eighteen years to be in or upon the premises;
- 31 (b) Neither the performance, nor any photograph, drawing, sketch, 32 or other pictorial or graphic representation of the performance, 33 displaying a portion of the breasts below the top of the areola or a 34 portion of the pubic hair, buttocks, genitals, or anus may take place 35 or be located so as to be visible to a minor who is or might be outside 36 of the live adult entertainment establishment; and
- 37 (c) A member of the public may not be permitted to enter into a 38 nonpublic portion of the live adult entertainment establishment, that 39 includes but is not limited to: The dressing rooms of the

- entertainers; other rooms provided for the benefit of employees; or the kitchen or storage areas. However, a person delivering goods and materials, food and beverages, or performing maintenance or repairs to the premises or equipment on the premises may be permitted into a nonpublic area to the extent required to perform the person's job duties.
- 7 (3) The responsibilities of the manager of a live adult 8 entertainment establishment include but are not limited to:
- 9 (a) A licensed manager shall be on duty at a live adult 10 entertainment establishment at all times adult entertainment is 11 provided or members of the public are present on the premises. The 12 name and license of the manager must be prominently posted during 13 business hours. The manager is responsible for verifying that a person 14 who provides adult entertainment within the premises possesses a 15 current and valid entertainer's license;
  - (b) The licensed manager on duty may not be an entertainer;
  - (c) The manager or an assistant manager licensed under this chapter shall maintain visual observation of each member of the public at all times an entertainer is present in the public or performance areas of the live adult entertainment establishment. If there is more than one performance area, or the performance area is of such a size or configuration that one manager or assistant manager is unable to visually observe, at all times, each entertainer, each employee, and each member of the public, a manager or assistant manager licensed under this chapter must be provided for each public or performance area or portion of a public or performance area visually separated from other portions of the live adult entertainment establishment; and
- 28 (d) The manager is responsible for and shall ensure that the 29 actions of members of the public, the entertainers, and all other 30 employees comply with this chapter.
  - (4)(a) The performance area of the live adult entertainment establishment where adult entertainment is provided must be a stage or platform at least eighteen inches in elevation above the level of the patron seating areas, and must be separated by a distance of at least eight feet from all areas of the premises to which a member of the public has access. A continuous railing affixed to the floor and measuring at least three feet in height and located at least eight feet from all points of the performance area must be installed on the floor of the premises to separate the performance area and the patron seating

The official shall issue a notice setting forth the basis for the action and the facts that constitute a threat of immediate serious injury or damage to person or property, and informing the licensee of the right to appeal the suspension to the designated hearing body under the same appeal provisions set forth in subsection (3) of this section. However, a suspension based on threat of immediate serious injury or damage may not be stayed during the pendency of the appeal.

33 <u>NEW SECTION.</u> **Sec. 15.** A license issued under this chapter is 34 subject to rules of the Washington state liquor control board relating 35 to the sale of intoxicating liquor. If there is a conflict between 36 this chapter and the applicable rules of the Washington state liquor control board, the rules of the Washington state liquor control board 38 control.
