1 AN ACT Relating to growth management hearings boards; and amending
2 RCW 36.70A.280.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 36.70A.280 and 1996 c 325 s 2 are each amended to read
5 as follows:

6 (1) A growth management hearings board shall hear and determine
7 only those petitions alleging either:

8 (a) That a state agency, county, or city planning under this
9 chapter is not in compliance with the requirements of this chapter,
10 chapter 90.58 RCW as it relates to the adoption of shoreline master
11 programs or amendments thereto, or chapter 43.21C RCW as it relates to
12 plans, development regulations, or amendments, adopted under RCW
13 36.70A.040 or chapter 90.58 RCW; or

14 (b) That the twenty-year growth management planning population
15 projections adopted by the office of financial management pursuant to
16 RCW 43.62.035 should be adjusted.

17 (2) ~~((A petition may be filed only by: (a) The state, or a county
18 or city that plans under this chapter; (b) a person who has
19 participated orally or in writing before the county or city regarding~~

1 ~~the matter on which a review is being requested; (c) a person who is~~
2 ~~certified by the governor within sixty days of filing the request with~~
3 ~~the board; or (d) a person qualified pursuant to RCW 34.05.530))~~ Only
4 a person directly impacted by a specific governmental action taken
5 under this chapter may bring an appeal related to any governmental
6 action taken under the authority of this chapter. For the purposes of
7 this subsection, a "person directly impacted" is a person (a) whose
8 interest is within the zone of interests to be protected or regulated
9 by this chapter, and (b) who will suffer an injury in fact if the
10 proposed action is taken.

11 (3) For purposes of this section "person" means any individual,
12 partnership, corporation, association, state agency, governmental
13 subdivision or unit thereof, or public or private organization or
14 entity of any character.

15 (4) When considering a possible adjustment to a growth management
16 planning population projection prepared by the office of financial
17 management, a board shall consider the implications of any such
18 adjustment to the population forecast for the entire state.

19 The rationale for any adjustment that is adopted by a board must be
20 documented and filed with the office of financial management within ten
21 working days after adoption.

22 If adjusted by a board, a county growth management planning
23 population projection shall only be used for the planning purposes set
24 forth in this chapter and shall be known as a "board adjusted
25 population projection". None of these changes shall affect the
26 official state and county population forecasts prepared by the office
27 of financial management, which shall continue to be used for state
28 budget and planning purposes.
