- 1 AN ACT Relating to providing vouchers for pregnant minors; adding
- 2 new sections to chapter 74.12 RCW; creating new sections; and declaring
- 3 an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that due to changes in
- 6 federal and state law the number of pregnant teenagers who need
- 7 alternative types of residences when they are unable to live with their
- 8 families is increasing. The legislature also finds that young pregnant
- 9 women can benefit from a structured environment that provides the
- 10 opportunity to learn essential parenting and life skills.
- 11 Therefore the legislature recognizes the need to increase the
- 12 number of licensed adult-supervised homes for young pregnant women.
- 13 <u>NEW SECTION.</u> **Sec. 2.** The definitions in this section apply
- 14 throughout sections 3 and 4 of this act unless the context clearly
- 15 requires otherwise.
- 16 (1) "Adult-supervised supportive living arrangement" means a
- 17 private family setting or other living arrangement, not including a
- 18 public institution, that is maintained as a family setting, as

- 1 evidenced by the assumption of responsibility for the care and control
- 2 of the minor parent and dependent child or the provision of supportive
- 3 services such as counseling, guidance, or supervision. The living
- 4 arrangement shall be licensed under chapter 74.15 RCW unless not
- 5 required to be licensed pursuant to RCW 74.15.020(4).
- 6 (2) "Department" means the department of social and health
- 7 services.
- 8 <u>NEW SECTION.</u> **Sec. 3.** The department shall operate a living
- 9 assistance program that provides vouchers for pregnant unemancipated
- 10 minors who are receiving assistance through the temporary assistance
- 11 for needy families program and are otherwise unable to live with their
- 12 parents, other family members, or a legal guardian. The program may
- 13 provide vouchers that can be used at state-approved adult-supervised
- 14 supportive living arrangements. Vouchers may not be provided for more
- 15 than twelve months.
- 16 <u>NEW SECTION.</u> **Sec. 4.** Adult-supervised supportive living
- 17 arrangements that qualify to participate in the program shall:
- 18 (1) Provide twenty-four hour per day adult supervision for minor
- 19 residents; and
- 20 (2) Provide a strong program component that actively engages minor
- 21 residents. Program components may include, but not be limited to,
- 22 parenting skills, job-readiness, and financial counseling.
- NEW SECTION. Sec. 5. Sections 2 through 4 of this act are each
- 24 added to chapter 74.12 RCW.
- 25 NEW SECTION. Sec. 6. If specific funding for the purposes of this
- 26 act, referencing this act by bill or chapter number, is not provided by
- 27 June 30, 1997, in the omnibus appropriations act, this act is null and
- 28 void.
- 29 <u>NEW SECTION.</u> **Sec. 7.** This act is necessary for the immediate
- 30 preservation of the public peace, health, or safety, or support of the
- 31 state government and its existing public institutions, and takes effect
- 32 immediately.
