1 AN ACT Relating to employers failure to pay industrial insurance
2 premiums; adding a new section to chapter 51.32 RCW; adding a new
3 section to chapter 51.04 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that there is a
6 continuing problem of employers illegally failing to insure their
7 workers for industrial insurance. When an employee of an employer who
8 has failed to insure his or her workers files a claim for benefits, the
9 department of labor and industries is forced to pass on the cost of the
10 benefits provided to legally insured employers in the same risk
11 classification. It is the intent of the legislature to place the
12 financial burden of paying for the industrial insurance benefits
13 provided to the injured employee on the illegally uninsured employer.

14 NEW SECTION. **Sec. 2.** A new section is added to chapter 51.32 RCW
15 to read as follows:

16 (1) If a worker is employed by an employer who has not secured the
17 payment of compensation as required by this title, the worker is
18 entitled only to medical benefits under chapter 51.36 RCW. However,

1 compensation in addition to medical benefits shall be paid if the
2 worker who is otherwise entitled provides payroll records, canceled
3 checks, pay stubs, or other documentation acceptable to the supervisor
4 of industrial insurance indicating that the worker had reason to
5 believe that premiums were paid for insuring the worker under this
6 title.

7 (2) All costs related to the benefits paid on behalf of a worker
8 whose employer did not secure coverage as required by this title are
9 the obligation of the employer and may not be charged by the department
10 to any other employer. If an employer fails to secure the payment of
11 compensation for his or her workers covered under this title and
12 benefits are paid as authorized under subsection (1) of this section,
13 the department may demand payment from the employer of the actual or
14 estimated cost, whichever is greater, of the benefits provided to the
15 worker. If the employer does not make payment within ten days from the
16 mailing of such demand by the department, the department may have and
17 recover judgment, warrant, or file liens as provided under this title
18 for such estimated costs or the actual costs, whichever is greater.

19 NEW SECTION. **Sec. 3.** A new section is added to chapter 51.04 RCW
20 to read as follows:

21 The director shall report biennially to the appropriate committees
22 of the legislature concerning the amount of money paid out by the
23 department, and not recovered under section 2(2) of this act, for
24 benefits provided under this title to employees of employers who failed
25 to secure the payment of compensation as required by this title.
