1 AN ACT Relating to the board of accountancy; and adding new
2 sections to chapter 43.131 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 43.131 RCW
5 to read as follows:

6 The board of accountancy and its powers and duties are terminated
7 June 30, 1999, as provided in section 2 of this act.
