## ENGROSSED HOUSE BILL 2414

- AN ACT Relating to outdoor burning; and amending RCW 70.94.743. 1
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 3 Sec. 1. RCW 70.94.743 and 1997 c 225 s 1 are each amended to read 4 as follows:
- 5 (1) Consistent with the policy of the state to reduce outdoor burning to the greatest extent practical: 6
- 7 (a) Outdoor burning shall not be allowed in any area of the state where federal or state ambient air quality standards are exceeded for 8 9 pollutants emitted by outdoor burning.
- 10 (b) Outdoor burning shall not be allowed in any urban growth area as defined by RCW 36.70A.030, or any city of the state having a 11 population greater than ten thousand people if such cities are 12 13 threatened to exceed state or federal air quality standards, and 14 alternative disposal practices consistent with good solid waste 15 management are reasonably available or practices eliminating production of organic refuse are reasonably available. In no event shall such 16 17 burning be allowed after December 31, 2000, except that for cities less
- than five thousand population neither within nor contiguous with any 18
- 19 nonattainment or maintenance area designated under the federal clean

- 1 air act, in no event shall such burning be allowed after December 31,
  2 2006.
- (c) Notwithstanding any other provision of this section, outdoor 3 4 burning may be allowed for the exclusive purpose of managing storm or flood-related debris. The decision to allow burning shall be made by 5 the entity with permitting jurisdiction as determined under RCW 6 7 70.94.660 or 70.94.755. If outdoor burning is allowed in areas subject to (a) or (b) of this subsection, a permit shall be required, and a fee 8 9 may be collected to cover the expenses of administering and enforcing 10 All conditions and restrictions pursuant to RCW 70.94.750(1) and 70.94.775 apply to outdoor burning allowed under this 11 section. 12
- 13 (2) "Outdoor burning" means the combustion of material of any type 14 in an open fire or in an outdoor container without providing for the 15 control of combustion or the control of emissions from the combustion.
- 16 (3) This section shall not apply to silvicultural burning used to 17 improve or maintain fire dependent ecosystems for rare plants or 18 animals within state, federal, and private natural area preserves, 19 natural resource conservation areas, parks, and other wildlife areas.
