- 1 AN ACT Relating to registration of counselors; and amending RCW
- 2 18.19.020 and 18.19.090.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 18.19.020 and 1991 c 3 s 19 are each amended to read 5 as follows:
- 6 Unless the context clearly requires otherwise, the definitions in 7 this section apply throughout this chapter.
- 8 (1) "Certified marriage and family therapist" means a person
- 9 certified to practice marriage and family therapy pursuant to RCW
- 10 18.19.130.
- 11 (2) "Certified mental health counselor" means a person certified to 12 practice mental health counseling pursuant to RCW 18.19.120.
- 13 (3) "Certified social worker" means a person certified to practice 14 social work pursuant to RCW 18.19.110.
- 15 (4) "Client" means an individual who receives or participates in counseling or group counseling.
- 17 (5) "Counseling" means employing any therapeutic techniques,
- 18 including but not limited to social work, mental health counseling,
- 19 marriage and family therapy, recreational therapy, and hypnotherapy,

- 1 for a fee that offer, assist or attempt to assist an individual or

- 15 **Sec. 2.** RCW 18.19.090 and 1991 c 3 s 24 are each amended to read 16 as follows:
- 17 The secretary shall issue a registration to any applicant who
- 18 submits, on forms provided by the secretary, the applicant's name,
- 19 address, occupational title, name and location of business, and other
- 20 information as determined by the secretary, including information
- 21 necessary to determine whether there are grounds for denial of
- 22 registration or issuance of a conditional registration under this
- 23 chapter or chapter 18.130 RCW. Applicants for registration shall
- 24 register as counselors or may register as hypnotherapists or
- 25 <u>recreational therapists</u> if employing hypnosis <u>or recreational therapy</u>
- 26 as a modality. Applicants shall, in addition, provide in their titles
- 27 a description of their therapeutic orientation, discipline, theory, or
- 28 technique. Each applicant shall pay a fee determined by the secretary
- 29 as provided in RCW 43.70.250, which shall accompany the application.
