- 1 AN ACT Relating to rabies vaccination for dogs, cats, and ferrets;
- 2 adding a new section to chapter 16.70 RCW; and prescribing penalties.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 16.70 RCW 5 to read as follows:
- 6 (1) All dogs, cats, and ferrets shall be vaccinated by a licensed 7 veterinarian against rabies in accordance with rules adopted by the 8 department of health that are based on the current compendium of animal 9 rabies control published by the national association of state public 10 health veterinarians.
- 11 (2) A dog, cat, or ferret is not required to be vaccinated against 12 rabies if a licensed veterinarian has examined the animal and has 13 certified in writing that at such a time vaccinations would endanger 14 the animal's health because of its age, infirmity, disability, illness, 15 or other medical considerations. An exempt animal shall be vaccinated 16 against rabies as soon as its health permits.
- 17 (3) Upon vaccination against rabies, a licensed veterinarian shall 18 provide the animal's owner and the animal control authority, or in the 19 absence of a local animal control authority, the local health

- 1 jurisdiction, with a rabies vaccination certificate that includes, but
- 2 is not limited to, the following information:
- 3 (a) The name, address, and telephone number of the owner;
- 4 (b) The date of vaccination;

- 5 (c) The expiration date of the vaccination;
- 6 (d) The species age, sex, color, breed, weight, and name of the 7 animal vaccinated;
  - (e) The rabies vaccine manufacturer;
- 9 (f) The vaccine lot and serial numbers;
- 10 (g) The type and brand of vaccine used;
- 11 (h) The route of administration of the vaccine; and
- 12 (i) The name, address, and telephone number of the administering 13 licensed veterinarian.
- The rabies vaccination certificate shall be maintained on file for a period of four years.
- 16 (4) The department of agriculture shall develop a standardized 17 rabies vaccination certificate form to be used by licensed 18 veterinarians for all dog, cat, and ferret rabies vaccinations 19 administered on or after January 1, 1999. The department of 20 agriculture may allow licensed veterinarians to develop vaccination 21 certificates that are consistent with the standardized certificate.
- 22 (5) Any person who fails to comply with this section is subject to 23 a civil penalty of fifty dollars.
