- 1 AN ACT Relating to the diagnosis and reporting of sexually
- 2 transmitted diseases; creating a new section; and declaring an
- 3 emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislature finds that in order to
- 6 address the HIV/AIDS epidemic in Washington state, AIDS case reporting
- 7 is not sufficient. Addressing this problem through the establishment
- 8 of a HIV infection surveillance system has been endorsed by both
- 9 private and public entities. No HIV infection surveillance system
- 10 currently exists in this state. Therefore, the state has the
- 11 opportunity to develop a HIV infection surveillance system that is both
- 12 sensitive to privacy and confidentiality issues as well as meeting
- 13 standards of the United States centers for disease control and
- 14 prevention for disease surveillance. Recognizing the complexity and
- 15 public health challenges posed by the establishment of a HIV infection
- 16 surveillance system and the changing epidemic, the legislature
- 17 establishes the HIV surveillance implementation task force.

- 1 (2) The governor shall appoint a fifteen member HIV surveillance 2 implementation task force, which shall be comprised of representatives 3 from the following:
- 4 (a) The chair of the state board of health or his or her designee;
- 5 (b) The chair of the governor's advisory council on HIV/AIDS or his 6 or her designee;
- 7 (c) The department of health;
- 8 (d) Local public health official;
- 9 (e) Persons with HIV disease;
- 10 (f) Community-based organizations serving those infected with HIV;
- 11 (g) Hospitals;
- 12 (h) Physicians;
- 13 (i) Laboratories;
- 14 (j) Epidemiologists;
- 15 (k) Information system specialist; and
- 16 (1) Other organizations as determined by the governor.
- 17 (3) The task force shall develop a state-wide pilot project for HIV
- 18 infection surveillance and complete a report for the state board of
- 19 health including recommendations on implementation of the pilot project
- 20 no later than October 1, 1998. The task force shall ensure the system
- 21 recommended for the pilot project meets guidelines for access to
- 22 federal funds.
- NEW SECTION. Sec. 2. This act is necessary for the immediate
- 24 preservation of the public peace, health, or safety, or support of the
- 25 state government and its existing public institutions, and takes effect
- 26 immediately.
