- 1 AN ACT Relating to allowing the pass-through of disposal fees for

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 81.77.160 and 1989 c 431 s 30 are each amended to read 6 as follows:
- 7 (1) The commission, in fixing and altering collection rates charged
- 8 by every solid waste collection company under this section, shall
- 9 include in the base for the collection rates:
- 10 $((\frac{1}{1}))$ (a) All charges for the disposal of solid waste at the
- 11 facility or facilities ((that the solid waste collection company is
- 12 required to use)) designated by a local jurisdiction under a local
- 13 comprehensive solid waste management plan or ordinance ((designating
- 14 disposal sites)); and
- 15 $\left(\left(\frac{2}{2}\right)\right)$ (b) All known and measurable costs related to
- 16 implementation of the approved county or city comprehensive solid waste
- 17 management plan.
- 18 (2) If a solid waste collection company files a tariff to recover
- 19 the costs specified under this section, and the commission suspends the

- 1 tariff, the portion of the tariff covering costs specified in this
- 2 section shall be placed in effect by the commission at the request of
- 3 the company on an interim basis as of the originally filed effective
- 4 date, subject to refund, pending the commission's final order. The
- 5 commission may adopt rules to implement this section.
- 6 (3) This section applies to a solid waste collection company that
- 7 has an affiliated interest under chapter 81.16 RCW with a facility, if
- 8 the total cost of disposal, including waste transfer, transport, and
- 9 disposal charges, at the facility is equal to or lower than any other
- 10 <u>reasonable and currently available option.</u>
- 11 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 81.16 RCW
- 12 to read as follows:
- 13 This chapter does not apply to a determination of the base for
- 14 collection rates for solid waste collection companies meeting the
- 15 requirements under RCW 81.77.160(3).
