14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

15 NEW SECTION. **Sec. 1.** (1) A budget is hereby adopted and, subject
16 to the provisions set forth in the following sections, the several
17 amounts specified in parts I through VIII of this act, or so much
18 thereof as shall be sufficient to accomplish the purposes designated,
19 are hereby appropriated and authorized to be incurred for salaries,

1 wages, and other expenses of the agencies and offices of the state and
2 for other specified purposes for the fiscal biennium beginning July 1,
3 1997, and ending June 30, 1999, except as otherwise provided, out of
4 the several funds of the state hereinafter named.

5 (2) Unless the context clearly requires otherwise, the definitions
6 in this section apply throughout this act.

7 (a) "Fiscal year 1998" or "FY 1998" means the fiscal year ending
8 June 30, 1998.

9 (b) "Fiscal year 1999" or "FY 1999" means the fiscal year ending
10 June 30, 1999.

11 (c) "FTE" means full time equivalent.

12 (d) "Lapse" or "revert" means the amount shall return to an
13 unappropriated status.

14 (e) "Provided solely" means the specified amount may be spent only
15 for the specified purpose. Unless otherwise specifically authorized in
16 this act, any portion of an amount provided solely for a specified
17 purpose which is unnecessary to fulfill the specified purpose shall
18 lapse.

4 year 1998 and \$3,282,500 of the general fund--state appropriation for
5 fiscal year 1999 are provided solely for a contract with the Washington
6 technology center. For work essential to the mission of the Washington
7 technology center and conducted in partnership with universities, the
8 center shall not pay any increased indirect rate nor increases in other
9 indirect charges above the absolute amount paid during the 1995-97
10 biennium.

11 (2) \$155,000 of the general fund--state appropriation for fiscal
12 year 1998 and \$155,000 of the general fund--state appropriation for
13 fiscal year 1999 are provided solely for a contract with the Washington
14 manufacturing extension partnership.

15 (3) \$9,964,000 of the general fund--federal appropriation is
16 provided solely for the drug control and system improvement formula
17 grant program, to be distributed in state fiscal year 1998 as follows:

18 (a) \$3,603,250 to local units of governments to continue the multi-

13 in dependency proceedings. Of this amount, a maximum of \$30,000 shall
14 be used by the department to contract for an evaluation of the
15 effectiveness of CASA/GAL in improving outcomes for dependent children.
16 The evaluation shall address the cost-effectiveness of CASA/GAL and to
17 the extent possible, identify savings in other programs of the state
18 budget where the savings resulted from the efforts of the CASA/GAL
19 volunteers. The department shall report to the governor and
20 legislature by October 15, 1998.

21 (9) \$75,000 of the general fund--state appropriation for fiscal
22 year 1999 is provided solely for state sponsorship of the "BIO 99"
23 international biotechnology conference and exhibition in the Seattle
24 area in 1999.

25 (10) \$698,000 of the general fund--state appropriation for fiscal
26 year 1998, \$697,000 of the general fund--state appropriation for fiscal
27 year 1999, and \$1,101,000 of the administrative contingency account
28 appropriation are provided solely for contracting with associate
29 development organizations.

31 year 1998 and \$50,000 of the general fund--state appropriation for
32 fiscal year 1999 are provided solely to expand the long-term care
33 ombudsman program.

3 NEW SECTION. **Sec. 201. FOR THE DEPARTMENT OF SOCIAL AND HEALTH**
4 **SERVICES.** (1) Appropriations made in part II of this act to the
5 department of social and health services shall initially be allotted as
6 required by this act. Subsequent allotment modifications shall not
7 include transfers of moneys between sections of this act except as
8 expressly provided in this act, nor shall allotment modifications
9 permit moneys that are provided solely for a specified purpose to be
10 used for other than that purpose.

11 (2) The department of social and health services shall not initiate
12 any services that will require expenditure of state general fund moneys
13 unless expressly authorized in this act or other law. The department
14 may seek, receive, and spend, under RCW 43.79.260 through 43.79.282,
15 federal moneys not anticipated in this act as long as the federal
16 funding does not require expenditure of state moneys for the program in
17 excess of amounts anticipated in this act. If the department receives
18 unanticipated unrestricted federal moneys, those moneys shall be spent
19 for services authorized in this act or in any other legislation
20 providing appropriation authority, and an equal amount of appropriated
21 state general fund moneys shall lapse. Upon the lapsing of any moneys
22 under this subsection, the office of financial management shall notify
23 the legislative fiscal committees. As used in this subsection,
24 "unrestricted federal moneys" includes block grants and other funds
25 that federal law does not require to be spent on specifically defined
26 projects or matched on a formula basis by state funds.

27 (3) The appropriations in sections 202 through 208 of this act
28 shall be expended for the programs and in the amounts listed in those
29 sections.

6 (1) \$16,510,000 of the general fund--state appropriation for fiscal
7 year 1998 and \$17,508,000 of the general fund--state appropriation for
8 fiscal year 1999 are provided solely for purposes consistent with the
9 maintenance of effort requirements under the federal temporary
10 assistance for needy families program established under P.L. 104-193.

11 (2) \$837,000 of the violence reduction and drug enforcement account
12 appropriation and \$7,228,000 of the general fund--federal appropriation
13 are provided solely for the operation of the family policy council, the
14 community public health and safety networks, and delivery of services
15 authorized under the federal family preservation and support act.
16 Within the funds provided, the family policy council shall contract for
17 an evaluation of the community networks with the institute for public
18 policy and shall provide for audits of ten networks. Within the funds
19 provided, the family policy council may build and maintain a geographic
20 information system database tied to community network geography.

21 (3) \$577,000 of the general fund--state fiscal year 1998
22 appropriation and \$577,000 of the general fund--state fiscal year 1999
23 appropriation are provided solely to contract for the operation of one
24 pediatric interim care facility. The facility shall provide
25 residential care for up to twelve children through two years of age.
26 Seventy-five percent of the children served by the facility must be in
27 need of special care as a result of substance abuse by their mothers.
28 The facility also shall provide on-site training to biological,
29 adoptive, or foster parents. The facility shall provide at least three
30 months of consultation and support to parents accepting placement of
31 children from the facility. The facility may recruit new and current
32 foster and adoptive parents for infants served by the facility. The
33 department shall not require case management as a condition of the
34 contract.

35 (4) \$481,000 of the general fund--state fiscal year 1998
36 appropriation and \$481,000 of the general fund--state fiscal year 1999
37 appropriation are provided solely for up to three nonfacility-based
38 programs for the training, consultation, support, and recruitment of
39 biological, foster, and adoptive parents of children through age three

1 in need of special care as a result of substance abuse by their
2 mothers, except that each program may serve up to three medically
3 fragile nonsubstance-abuse-affected children. In selecting
4 nonfacility-based programs, preference shall be given to programs whose
5 federal or private funding sources have expired or that have
6 successfully performed under the existing pediatric interim care
7 program.

8 (5) \$640,000 of the general fund--state appropriation for fiscal
9 year 1998 and \$640,000 of the general fund--state appropriation for
10 fiscal year 1999 are provided solely to fund Second Substitute Senate
11 Bill No. 5710 (juvenile care and treatment), including section 2 of the
12 bill. Amounts provided in this subsection to implement Second
13 Substitute Senate Bill No. 5710 must be used to serve families who are
14 screened from the child protective services risk assessment process.
15 Services shall be provided through contracts with community-based
16 organizations. If neither bill is enacted by June 30, 1997, the
17 amounts provided in this subsection shall lapse.

18 (6) \$594,000 of the general fund--state appropriation for fiscal
19 year 1998, \$556,000 of the general fund--state appropriation for fiscal
20 year 1999, and \$290,000 of the general fund--federal appropriation are
21 provided solely to fund the provisions of Engrossed Second Substitute
22 House Bill No. 2046 (foster parent liaison). The department shall
23 establish a foster parent liaison in each department of social and
24 health services region of the state and contract with a private
25 provider to implement a recruitment and retention program for foster
26 parents and adoptive families. The department shall provide a minimum
27 of two hundred additional adoptive and foster home placements by June
28 30, 1998. If the bill is not enacted by June 30, 1997, the amounts in
29 this subsection shall lapse.

30 (7) \$433,000 of the fiscal year 1998 general fund--state
31 appropriation, \$395,000 of the fiscal year 1999 general fund--state
32 appropriation, and \$894,000 of the general fund--federal appropriation
33 are provided solely to increase the rate paid to private child-placing
34 agencies.

35 (8) \$580,000 of the general fund--state appropriation for fiscal
36 year 1998 and \$580,000 of the general fund--state appropriation for
37 fiscal year 1999 are provided solely for development and expansion of
38 child care training requirements and optional training programs. The
39 department shall adopt rules to require annual training in early

1 childhood development of all directors, supervisors, and lead staff at
2 child care facilities. Directors, supervisors, and lead staff at child
3 care facilities include persons licensed as family child care
4 providers, and persons employed at child care centers or school age
5 child care centers. The department shall establish a program to fund
6 scholarships and grants to assist persons in meeting these training
7 requirements. The department shall also develop criteria for approving
8 training programs and establish a system for tracking who has received
9 the required level of training. In adopting rules, developing
10 curricula, setting up systems, and administering scholarship programs,
11 the department shall consult with the child care coordinating committee
12 and other community stakeholders.

13 (9) The department shall provide a report to the legislature by
14 November 1997 on the growth in additional rates paid to foster parents
15 beyond the basic monthly rate. This report shall explain why
16 exceptional, personal, and special rates are being paid for an
17 increasing number of children and why the amount paid for these rates
18 per child has risen in recent years. This report must also recommend
19 methods by which the legislature may improve the current foster parent
20 compensation system, allow for some method of controlling the growth in
21 costs per case, and improve the department's and the legislature's
22 ability to forecast the program's needs in future years.

23 (10) \$100,000 of the general fund--state appropriation for fiscal

32 individual task force members or by the organizations that the
33 individuals represent. No task force member shall be eligible for
34 reimbursement of expenses under RCW 43.03.050 or 43.03.060. Nothing in
35 this subsection prevents the legal aid programs from using funds
36 appropriated in this act to reimburse their representatives or the
37 individuals representing legal clients.

38 (iii) The task force will meet at least four times during the first
39 year of the biennium and as frequently as necessary thereafter at

1 mutually agreed upon times and locations. Any member of the task force
2 may place items on meeting agendas. Members present at the first two
3 task force meetings shall agree upon a format for subsequent meetings.

4 (b) The legislature recognizes that farmworkers have the right to
5 receive basic information and to consult with attorneys at farm labor
6 camps without fear of intimidation or retaliation. It is the intent of
7 the legislature and in the interest of the public to ensure the safety
8 of all persons affected by legal aid programs' farm labor camp outreach
9 activities. Legal aid program employees have the legal right to enter
10 the common areas of a labor camp or to request permission of employees
11 to enter their dwellings. Employees living in grower supplied housing
12 have the right to refuse entry to anyone including attorneys unless
13 they have a warrant. Individual employees living in employer supplied
14 housing do not have the right to force legal aid program employees to
15 leave common areas of housing (outside) as long as one person who
16 resides in the associated dwellings wants that person to be there. Any
17 legal aid program employee wishing to visit employees housed on grower
18 property has the right to enter the driveway commonly used by the
19 housing occupants. This means that if agricultural employees must use
20 a grower's personal driveway to get to their housing, legal aid program
21 employees also may use that driveway to access the housing without a
22 warrant so long as at least some of the housing is occupied. When
23 conducting outreach activities that involve entry onto labor camps,
24 legal aid programs shall establish and abide by policies regarding
25 conduct of outreach activities. The policies shall include a
26 requirement that legal aid program employees identify themselves to
27 persons whom they encounter at farm labor camps. The legal aid
28 programs shall provide copies of their current outreach policies to
29 known agricultural organizations and shall provide copies upon request
30 to any owner of property on which farmworkers are housed. Legal aid
31 program employees involved in outreach activities shall attempt to
32 inform operators of licensed farm labor camps or their agents, and
33 known grower organizations of the approximate time frame for outreach
34 activities and shall cooperate with operators of farm labor camps at
35 which farmworkers are housed in assuring compliance with all pertinent
36 laws and ordinances, including those related to trespass and
37 harassment. Employers who believe that Evergreen Legal Services
38 Outreach Guidelines have been violated shall promptly provide all
39 available information on the alleged violation to the director of

1 Evergreen Legal Services and to the chair of the Task Force on
2 Agricultural Interests/Legal Aid Relations. Evergreen Legal Services
3 will promptly investigate any alleged violations of the outreach
4 guidelines and inform the complaining party of the result. If the
5 resolution of the investigation is not satisfactory to the complainant,
6 the matter shall be placed on the Task Force agenda for discussion at
7 the next scheduled meeting. Employers who believe that Evergreen Legal
8 Services staff members have trespassed should immediately contact local
9 law enforcement authorities.

10 (c) It is the intent of the legislature to provide the greatest
11 amount of legal services to the largest number of clients by
12 discouraging inefficient use of state funding for indigent legal
13 representation. To this end, it is the intent of the legislature that,
14 prior to the commencement of litigation against any private employer
15 relating to the terms and conditions of employment legal aid programs
16 receiving funds appropriated in this act make good faith written demand
17 for the requested relief, a good faith offer of settlement or an offer
18 to submit to nonbinding arbitration prior to filing a lawsuit, unless
19 the making of the offer is, in the opinion of the director of the legal
20 services program or his/her designee, clearly prejudicial to: (i) The
21 health, safety, or security of the client; or (ii) the timely
22 availability of judicial relief. The director of the legal aid program
23 may designate not more than two persons for purposes of making the
24 determination of prejudice permitted by this section.

25 (d)(i) The legislature encourages legal aid programs to devote
26 their state and nonstate funding to the basic, daily legal needs of
27 indigent persons. No funds appropriated under this act may be used for

16 (C) For 1995-96, the 1994-95 enrollment percent reduced by 25

21 (6) At the request of any interdistrict cooperative of at least 15

25 (v) Any available federal funds are insufficient to address the
